# **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information on live animal exports which we received on 03 October 2018. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"Please provide all paperwork including journey logs and veterinary certificates for the journey undertaken on August 16th 2018 for the following vehicles which were transporting live sheep:

## 24 BKX 5

Please see attached Journey Logs and Intra Trade Animal Health Certificates for the above named vehicle entitled Appendices 1 to 4.

## **R730 EUB**

Please find attached the Intra Trade Animal Health Certificate for the above named vehicle (Appendix 5). The transporter of this consignment has not yet returned the Journey Log used to accompany this consignment. APHA has written to the transporter in question on two occasions to return this Journey Log. The Transporter will not be granted any further journey logs until all of the outstanding documents are returned.

#### UKZ 4562"

Please find attached the Intra Trade Animal Health Certificate for the above named vehicle (Appendix 6). The transporter of this consignment has not yet returned the Journey Log used to accompany this consignment. APHA has written to the transporter in question on two occasions to return this Journey Log. The Transporter will not be granted any further journey logs until all of the outstanding documents are returned.

Some of the information has been redacted under Section 38, Section 40(2), read in conjunction with 40(3)(a)(i) of the Freedom of Information Act (2000).

## Section 38

Section 38 refers to the exemption from the duty to provide information if it would, or would be likely to affect anyone's health or safety.

The exemption in Section 38 is subject to a Public Interest Test to ensure it is being appropriately applied.

## **Public Interest Test**

We recognise that there is a general presumption in favour of transparency and openness concerning our work, and providing the general public with the right to request access to information held by public authorities.

We also recognise that there is a public interest in disclosure of this specific information in order to increase this transparency and aid well-informed debates concerning the welfare and transportation of animals, and the individuals associated with them.

However, we feel that there is a stronger public interest in withholding the information as the full addresses, including the county of origin, the destination and/or rest stops, transporter details and individual names would identify further information and would, or would be likely to, endanger the health and safety of staff. This poses a substantial risk to the health and safety of individuals associated with the transportation of animals that would be of significant severity and is likely to occur in some cases. We consider this to be a significant factor in favour of maintaining the exemption.

APHA has balanced the real threat to the health and safety of individuals which disclosure of the requested information would be likely to cause, against the public interest arguments in favour of disclosure. In this instance the APHA does not consider that disclosing the information requested in order to inform public debate and to promote accountability and transparency would justify the risk to individuals' health and safety.

## Section 40

Some of the information contained within the requested documents have been withheld under section 40(2), read in conjunction with 40(3)(a)(i) (third party personal data), of the FOIA as the information constitutes personal data relating to a third party. Section 40(2), read in conjunction with 40(3)(a)(i), of the FOIA provides that personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 2018 (DPA).

APHA consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 of the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute 'fair' processing of the personal data, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA. Therefore, we have concluded that this information is exempt from disclosure under section 40 of the FOIA

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
