Summary of consultation

The Ministry of Housing, Communities and Local Government (MHCLG) is currently looking at how we publish our statistical releases, trying to move towards providing greater coherence in the way we publish them – away from publication by source or data collection and towards a more thematic, consistent approach. Bringing statistics together in this way will provide users with an easier way to find the statistics on their topic of interest rather than the current process of having to go to different statistical releases.

The department produces the Local Authority Housing Statistics (LAHS) bulletin in January each year. The statistical bulletin currently covers a number of topics collected as part of the much broader LAHS data collection. The objective of this paper is to set out the department's proposed changes to the LAHS statistical bulletin.

To make the commentary of LAHS data more accessible and placed in better context, the department is proposing to discontinue the LAHS bulletin that is published every year and move its content and commentary to be published instead in other statistical bulletins throughout the year.

The department is not proposing any changes to the underlying LAHS data return nor to the content of the published tables although the timing of their publication may change and usually these will be made available earlier. A proportion of these data are already used and reported in other statistical bulletins published by the department and are not included in the LAHS statistical bulletin. These proposals are consistent with this approach. They are also in line with the Office for Statistical Regulation's recommendations following their review of housing statistics¹.

We would like to take this opportunity to get feedback from users on how they use the bulletin and ask for feedback on the proposed changes.

Scope of the consultation

Topic of this consultation:	This consultation seeks views on the proposed discontinuing of the Local Authority Housing Statistics (LAHS) bulletin that is published in January every year and for its content to be published in other statistical bulletins throughout the year.
Scope of this consultation:	We are considering how best to meet the needs of users in a cost-effective way, while broadening the utility of the data itself. There are no proposed changes to the underlying data collected and published from the LAHS return and therefore, changes to the data are outside the scope of this consultation. However, the department welcomes user feedback at part of its continuous effort to improve statistical output. Geographical scope:	These proposals relate to statistics for England only.

Local Authority Housing Statistics

Introduction

- This document invites comments on The Ministry of Housing, Communities and Local Government (MHCLG) proposals for the future production of the Local Authority Housing Statistics (LAHS) bulletin. The latest published bulletin can be found at: https://www.gov.uk/government/statistics/local-authority-housing-statistics-year-ending-march-2018.
- 2. The LAHS is badged as National Statistics with its bulletin published annually in January. It reports several topics such as changes in stock, waiting lists, rents and stock condition that are collected as part of the much broader LAHS data collection. Other parts of the LAHS dataset are already being presented in other more topical statistical bulletins such as Social Housing Sales, with the latest release available at https://www.gov.uk/government/statistics/social-housing-sales-in-england-2017-to-2018 and Affordable Housing Supply, with the latest release available at https://www.gov.uk/government/statistics/affordable-housing-supply-in-england-2017-to-2018.
- 3. MHCLG has a statutory duty, in accordance with the Statistics and Registration Act 2007, to ensure its statistics meets user needs and engage users on changes to the department's statistical output. This consultation meets the requirements for National Statistics to consult its users where major changes are proposed.
- 4. We review here the current reporting scheme for LAHS data and propose how this scheme may be improved to better meet user needs.

The current reporting scheme for LAHS data

The LAHS bulletin is currently published in the January after the reporting year. It
presents a broad range of topics on the stock, lettings, rents and condition of local
authority owned properties. It reports Private Registered Provider (PRP) owned stock

(first published by the Regulator for Social Housing in the Single Data Return (SDR) in October after the reporting year) and calculates a total social housing stock figure for England. It also contains information on local authority housing waiting lists and evictions carried out by local authority landlords. The bulletin does not cover all topics provided in the LAHS data return.

- 6. At the same time as the publication of the LAHS bulletin the full LAHS data return is published containing all the data provided to the department. A number of associated live tables are also published with the bulletin, which are;
 - a. LT 115 Dwelling stock: PRP stock, by district; England, since 1997;
 - b. LT 116 Local authority stock, by district; England, since 1994;
 - c. LT 600 Numbers of households on local authorities' housing waiting lists, by district; England, since 1997;
 - d. LT 602 Local authority owned dwellings let by local authority; England, since 2000-01;
 - e. LT 612 Local authority vacant dwellings; England, since 1989;
 - f. LT 702 Local authority average weekly rents, by district; England, since 1998:
 - g. LT 704 Rents: Private Registered Provider (PRP) rents, by district; England since 1997;
 - h. LT 706 Local authority social rented stock and average social rent by size of property; England, 2017-18;
 - i. LT 707 Local authority social rented stock and average social rent by size of property; London, 2017-18.
- 7. LAHS data is used and published in other bulletins and live tables which are summarised in table 1.

Current issues with the reporting scheme

- 8. The current reporting scheme for LAHS data does not have a clear consistent approach which may make it hard for users to navigate. Some sections of the data are embedded into thematic bulletins such as Social Housing Sales and Affordable Housing Supply. However, the LAHS bulletin has no clear theme other than its primarily data reported in the LAHS return.
- 9. The current scheme is likely to create barriers for users accessing LAHS data. It is likely that users will primarily search for a topic rather than a named data return. So, for a new user to find information on non-decent social homes using online search engines they might be directed first to live table 119 (Stock of non-decent homes in the Social Rented Sector), which would then require them to identify the sources, and in turn to search for them. If they were to search via the department's gov.uk statistics page they would need to have prior knowledge of the name of the data return.
- 10. The thematic approach of bulletins such as Social Housing Sales and Affordable Housing Supply collates information from several different sources and then presents a more consistent and comprehensive view of the topic. The current reporting scheme for the LAHS bulletin, based on the data collection survey rather than topic area, requires

the user to consult multiple publications to gather a rounded a full picture: For example, to gain a full understand of non-decent social stock the user would need to visit live table 119 as well as consult the RSH Statistical Data Return, LAHS and English Housing Survey reports.

Meeting user needs

- 11. User groups of the statistic are varied including: MHCLG and other government departments and agencies, local government, local government associations, academics, media, and community and campaign groups, as well as interested members of the public.
- 12.LAHS data cover a wide range of topics related to social housing and the role of local authorities and as such is used regularly for different purposes. It is not proposed that the data changes, and the full data return will be made publicly available as is now although publication timings may change. This should limit the impact of the proposed changes to users that primary use the data directly.

Proposed changes

- 13. LAHS is badged as National Statistics and as such MHCLG has a statutory duty, in accordance with the Statistics and Registration Act 2007, to ensure its statistics meet user needs and engage users on any proposed changes. We outline here the proposed changes to the reporting of LAHS data and invite opinion from the wider user base and those who may not previously have engage with the statistic. In all cases:
 - MHCLG will continue to publish the LAHS data return annually;
 - The LAHS bulletin that is published in the January after the end of the reporting year would be discontinued as of the 2018-19 data return (which is set for publication in January 2020).
- 14. The data currently published in Social Housing Sales and Affordable Housing Supply bulletins remain the same and are summarised in table 2.

- 15. The data presented in the LAHS bulletin will be moved to a number of different bulletins currently published by the department. A full summary of the proposed changes can be seen in table 2.
- 16. It is proposed that the tables for sections of the LAHS data return will be published at the same time as they appear in bulletins. A summary of the changes in the publication of the date is set out in table 3.

Annex A
