Additional Provision 2 & Supplementary Environmental Statement 2

- Additional Provision 2 deposited on 8 February 2019
- Additional Provision 2 incudes a number of changes to the scheme agreed with petitioners, changes requested by the Select Committee, as well as those resulting from ongoing design development
- Deposit of the Additional Provision has triggered a fresh petitioning period for those whose property or interests are directly or specially affected by the changes proposed in the Additional Provision. The petitioning period will end on <u>15 March 2019</u>
- The Additional Provision Environmental Statement and Supplementary Environmental Statement are subject to a consultation, to inform the debate at Third Reading in the House of Commons. The consultation period will end on 29 March 2019

Next steps

- Aim is for the Select Committee to resume its hearings in late March (25 March)
- Expect the sessions before the Easter Recess to be limited to briefings, site visit and any right to be heard challenge hearings
- Easter Recess is 5 April 22 April inclusive
- After the Easter Recess (23 April), the expectation is subject to seeing the petitions received that
 we will start with the in-principle case for Parkgate, the proposed new power supply connection
- Expect to then hear the petitions in the same order as before, working through the route south to north, with route wide petitions (eg environmental NGOs, utilities etc) at the end
- Expect Select Committee to publish a third, final report at the end of their hearings
- Aim is for Select Committee to complete its hearings and report the Bill by June
- Select Committee stage will be followed by Public Bill Committee and Report/Third Reading

HS2 update

West Midlands to Crewe | March 2019

High Speed Two (HS2) is the new high speed railway for Britain. This newsletter is about Phase 2a of the railway, which will run from the West Midlands to Crewe, passing through parts of Staffordshire and Cheshire. We recognise that local people may be concerned about the potential impacts of HS2. This newsletter explains the latest plans and the support available.

Latest plans

HS2 will form the new backbone of our country's railway system and be the first North-South railway built in the UK for over a century. It will increase rail capacity and better connect our largest cities, while creating new jobs.



Key changes

We have updated our plans for Phase 2a in our second 'additional provision' to the Bill. Many of the changes are a result of requests from local people and organisations. They are also the result of design improvements, and more information becoming available, AP2 related engagement


Update

Phase 2a CoCP demolition changes

Code of Construction Practice & demolition

- At the last meeting the disapplication of the sections of the Building Act 1984 in AP2 was explained.
- Related to this it is proposed that the protections that relate to demolitions be expanded.
- The draft of these additions to the Draft Phase 2a Code of Construction Practice were circulated to Forum members on 27 February.
- Written comments requested by COP 4th April.

Controls related to demolition

- All the controls contained in the draft CoCP already apply to demolition whether or not there is an explicit reference to demolition.
- In several sections explicit reference is made to demolition activities eg air quality, ecology, waste and materials and electro-magnetic inference.
- Additional sections of the CoCP need to be considered in this context.
- Two additions to the draft CoCP proposed:
 - Demolition section at the end of Chapter 5 General Requirements
 - Template added as annex 4

Demolition section in Ch 5

- Requirement to submit to a
 Demolition Plan to the relevant
 local authority for consultation
 at least six weeks before
 commencing demolition.
- The measures relating to these themes will be drawn from relevant sections of CoCP.
- Contents set out in 1.1.2 & 1.1.3
- Requirements in para 1.1.2 ensure that the matters that could be addressed through section 82(1)(j) are always covered.
- Focused on environmental protection

1.1.2 Demolitions Plans will *always* contain management measures that relate to:

general requirements e.g. working hours, site security and hoarding

measures to control dust and construction plant and vehicles emissions

site investigation and remediation works for contaminated land

measures to reduce potential noise and vibration impacts

measures to reduce construction vehicle impacts in line with the local traffic management plan

Demolition section in Ch 5

• 1.1.3 reflects the requirements of 82(1) (a) to (i)

1.1.3 the Demolition
Plan will where
reasonably necessary
require the lead
contractors to:

shoring up adjacent buildings

disconnecting and sealing sewers & drains

making good the surface of the ground disturbed

Disconnecting utilities

Removal of material or rubbish

arrangements with regard to burning

Weatherproofing of building

making good any damage to an adjacent buildings caused by the demolition

Planning Forum Note 4: Consultation

- This Note details the environmental bodies considered statutory consultees by Schedule 17(18), including the circumstances where a planning authority should consult them
- HS2 shared this Note with the statutory consultees
- **Historic England** required further clarity on the wording in the Note which affects their interests:
 - "Where a planning authority considered that a request for approval relates to matters which affect a <u>site</u>
 <u>of archaeological or historic interest</u> they must within 5 days...invite the body to make representations"
- HS2 sought legal advice and have amended the Note on the basis that the planning authority ought to refer to the NPPF for the purposes of defining a site of archaeological or historic interest
- HS2 will share the revised Note after today's meeting so local authorities can review and comment on the amendments

- The Phase 2a Schedule 17 Statutory Guidance will be published by the DfT upon Royal Assent

- 6 February: construction teams named that will be awarded contracts to deliver London terminus and Old Oak Common.

Phase 2a

- ▶ 8 February: AP2 deposited before Parliament.
- March: route wide newsletter issued by HS2 Ltd
- Qualifying Authority process: expect to formally write to authorities in April/ May inviting them to confirm if they intend becoming a Qualifying Authority.

Phase 2b

Working towards consulting on potential further changes on 2b this year including some to facilitate Northern Powerhouse Rail.
