Consultation on future engagement arrangements for EPACs and RLFACs

I am pleased to launch this consultation detailing proposals, subject to passage of the Public Bodies Bill, on future arrangements for the role of Environment Agency's statutory Environment Protection Advisory Committees (EPACs) and Regional and Local Fisheries Advisory Committees (RLFACs) in England.

The Committees have provided a valuable service since they were established in the Environment Act 1995. Environmental challenges and opportunities evolve and it is important that the approaches we have to engage with and address them are flexible, innovative and local. Sixteen years on from the Environment Act it is important that we revisit these arrangements and look at the future engagement framework we need to best deliver outcomes for the environment.

I am writing to invite your views and comments on the proposals detailed in this consultation. The current committee Chairs and members have helped to develop these proposals in discussion with their local stakeholders. I would like to take the opportunity to thank all those that have contributed thus far.

Views are being sought on:

1. If you agree with the principle of abolition of the Environment Agency's statutory Environment Protection Advisory Committees and Regional and Local Fisheries Advisory Committees and the establishment of flexible non-statutory arrangements?
2. If you agree with the proposed high level principles against which to design future stakeholder engagement? Do you think there are there any gaps?
3. If you support the more flexible and region specific approaches being developed to allow more engagement at the local level (Appendix D)? Do you think there any gaps?
