


Fishing Gear requirements and Landing Obligation exemptions 2019

Applicable to Demersal Towed Gears Fishing in the Celtic Sea

(Excluding Nephrops Vessels and Beam Trawlers)



Introduction

This document explains rules on which fishing gear you should be using in the Celtic Sea area (also known as the Celtic Sea Protection Zone). This area includes VIIf, VIIg, and the part of VIIj North of 50° N and East of 11° W. It also summarises which Landing Obligation exemptions are available to you.

This guidance is for all sizes of fishing vessel (including those under 10 metres). It does not cover IFCA byelaws – please consult your local IFCA for further information.

General fishing gear rules:



- All mesh sizes given in this document are minimum sizes. You can choose to use a larger mesh than that stated.
- Twine thickness requirements are 6mm maximum for single twine and 4mm for double twine

Gear selectivity requirements

All mesh sizes specified are the minimum. Please note that a further proposed amendment to the rules below will come into force in 2020 that will enable demersal trawlers with more than 10% of sole to use an 80mm codend and 120mm square mesh panel.

Anglerfish, Hake, or Megrim combined - if more than 55 % of your catch	3) 80 mm cod-end and 160 mm square mesh panel		
	4) 80 mm cod-end and 2 m x 100 mm square mesh cylinder		



Marine Management Organisation

If you are fishing in ICES Area VIIf East of 5° West and there are less than 10 % Gadoids in your catch	80 mm cod-end and 120 mm square mesh panel
Pelagic species	16mm cod-end
Nephrops fishery (>5% NEP)	Please see separate guidance.

Landing Obligation exemptions

In the table below is a brief summary of exemptions from the Landing Obligation for these fisheries which allow you to discard fish. All quantities of fish discarded under the Landing Obligation must be recorded in your logbook, but will not come off your quota.

We recommend that you also read the relevant landing obligation guidance for further information.
