Penzance to St Mawes

PSM 4: Loe Bar to Mullion Cove

Part 4.1: Introduction

Start Point: Loe Bar (grid reference: SW64142425) **End Point:** Mullion Cove (grid reference: SW66771787) Relevant Maps: PSM 4a to PSM 4e

- 4.1.1 This is one of a series of linked but legally separate reports published by Natural England under section 51 of the National Parks and Access to the Countryside Act 1949, which make proposals to the Secretary of State for improved public access along and to this stretch of coast between Penzance and St Mawes.
- 4.1.2 This report covers length PSM 4 of the stretch, which is the coast between Loe Bar and Mullion Cove. It makes free-standing statutory proposals for this part of the stretch, and seeks approval for them by the Secretary of State in their own right under section 52 of the National Parks and Access to the Countryside Act 1949.
- 4.1.3 The report explains how we propose to implement the England Coast Path ("the trail") on this part of the stretch, and details the likely consequences in terms of the wider 'Coastal Margin' that will be created if our proposals are approved by the Secretary of State. Our report also sets out:
 - any proposals we think are necessary for restricting or excluding coastal access rights to address particular issues, in line with the powers in the legislation; and
 - any proposed powers for the trail to be capable of being relocated on particular sections ("rollback"), if this proves necessary in the future because of coastal change.
- 4.1.4 There is also a single Overview document for the whole of this stretch of coast, explaining common principles and background. This and the other individual reports relating to the stretch should be read in conjunction with the Overview. The Overview explains, among other things, how we have considered any potential environmental impacts of improving public access to this part of the coast, and this report, and other separately published assessments we refer to, then provides more detail on these aspects where appropriate.

Part 4.2: Proposals Narrative

The trail:

- 4.2.1 Follows the existing South West Coast Path as currently walked and managed between Loe Bar and Gunwalloe Quarry (route sections PSM-4-S001 to PSM-4-S011), Gunwalloe Quarry to Halzephron House (route sections PSM-4-S014 to PSM-4-S029), and Halzephron Cove to Mullion Cove (route sections PSM-4-S035 to PSM-4-S107). The existing South West Coast Path generally follows public rights of way along these lengths. See maps PSM 4a to PSM 4e and associated table 4.3.1 below for more details.
- 4.2.2 Differs from the existing South West Coast Path along a 300m length at Gunwalloe Quarry (route sections PSM-4-S012 and PSM-4-S013). This length follows a current diversion of the South West Coast Path due to coastal erosion. This new length follows an existing public right of way. See map PSM 4b and associated table 4.3.2 below for details.
- 4.2.3 Also differs from the existing South West Coast Path along a 400m length between Halzephron House and Halzephron Cove (PSM-4-030 to PSM-4-034). This new length does not follow an existing walked route and is necessary due to coastal erosion on the cliffs adjacent to Halzephron House. See map PSM 4b and associated table 4.3.2 below for details
- 4.2.4 Mainly follows the coastline quite closely and maintains good views of the sea. At Halzephron House the new route will run behind a hedge bank through two fields before re-joining the existing line of the South West Coast Path. There will be limited sea views for approximately 240 metres.

The South West Coast Path

4.2.5 For the majority of this report length we propose adopting the walked line of the South West Coast Path as the line of the England Coast Path. However, there are places where we have proposed to realign the route due to coastal erosion and furthermore there may be places where the walked line differs slightly from the route originally approved by the Secretary of State, as the path has evolved over time to cope with coastal erosion and other processes. In both situations, as explained at part 6a of the Overview, assuming these proposals are approved we intend to use a separate variation report to the Secretary of State to change the route of the existing national trail to reflect the approved line of the England Coast Path insofar as the two are different.

Protection of the environment:

In this part of the report, we explain how we have taken account of environmental protection objectives in developing our proposals for improved coastal access.

- 4.2.6 The following designated sites affect this length of coast:
 - The Lizard Special Area of Conservation (SAC)
 - Lizard Point Special Area of Conservation (SAC)
 - Loe Pool Site of Special Scientific Interest (SSSI) for its geological/wildlife interest
 - Baulk Head to Mullion Site of Special Scientific Interest (SSSI) for its geological/wildlife interest
 - Cliff castle W of Gunwalloe Church Scheduled Ancient Monument (SAM)
 - Wayside cross in Gunwalloe churchyard, 0.75m east of the church Scheduled Ancient Monument (SAM)

- Medieval wayside cross base, 10m south of Gunwalloe church Scheduled Ancient Monument (SAM)
- Two round barrows on Pedngwinian Head Scheduled Ancient Monument (SAM)
- Three bowl barrows 350m north of Poldhu Cove Scheduled Ancient Monument (SAM)

Map C and Map D in the Overview shows the extent of the designated areas listed.

- 4.2.7 We consider that the coastal environment, including features of the sites listed above, along this length of coast is unlikely to be sensitive to the improvements to coastal access envisaged and that no special measures are needed in respect of our proposals.
- 4.2.8 Natural England is satisfied that the proposals for coastal access in this report are made in accordance with relevant environmental protection legislation. In respect of cultural heritage, we have taken advice from Historic England and others before confirming this conclusion. For more information about how we came to this conclusion in respect of the natural environment; see the following assessments of the access proposals that we have published separately:
 - A Habitats Regulations Assessment relating to any potential impact on the conservation objectives of European sites.
 - Our Nature Conservation Assessment, in which we document our conclusions in relation to other potential impacts on nature conservation.

Part 6b of the Overview includes some contextual information about protecting the environment along this length of coast.

Accessibility:

- 4.2.9 There are few artificial barriers to accessibility on the proposed route. However, the natural coastal terrain is often challenging for people with reduced mobility and this is the case on sections of our proposed route because:
 - The trail would cross a shingle beach at Loe Bar;
 - It would follow an uneven grass or bare soil path with steep gradients in places along most of the length covered in this report;
 - There are steps in places such as at Polurrian Cove and Mullion Cove.

See part 6a of the Overview - 'Recreational issues' - for more information.

Where we have proposed exercising statutory discretions:

- 4.2.10 **Landward boundary of the coastal margin:** We have used our discretion on some sections of the route to map the landward extent of the coastal margin to an adjacent physical boundary such as a fence line, pavement or track to make the extent of the new access rights clearer. See Tables 4.3.1 and 4.3.2 below.
- 4.2.11 At Polbream and at Mullion we have used our discretion to propose the inclusion of additional, more extensive landward areas within the coastal margin, to secure or enhance public enjoyment of this part of the coast. The owner of this land is content for us to propose this.
- 4.2.12 The Proposals Tables show where we are proposing to alter the default landward boundary of the coastal margin. These proposals are set out in columns 4b and 4c of table 4.3.1 and 5b and 5c of

table 4.3.2. Where these columns are left blank, we are making no such proposals, so the default landward boundary applies. See the note relating to Columns 4b & 4c above Table 4.3.1 and the note relating to Column 5b & 5c above Table 4.3.2 explaining what this means in practice.

See also part 3 of the Overview - 'Understanding the proposals and accompanying maps', for a more detailed explanation of the default extent of the coastal margin and how we may use our discretion to adjust the margin, either to add land or to provide clarity.

4.2.13 **Coastal erosion:** Natural England is able to propose that the route of the trail would be able to change in the future, without further approval from the Secretary of State, in response to coastal change. This would happen in accordance with the criteria and procedures for 'roll-back' set out in part 7 of the Overview.

Natural England may only propose the use of this roll-back power:

- as a result of coastal erosion or other geomorphological processes or encroachment by the sea,
 or
- in order to link with other parts of the route that need to roll back in direct response to such changes.
- 3.2.14 Column 3 of table 4.3.1 and column 4 of table 4.3.2 indicates where roll-back has been proposed in relation to a route section. Where this is the case, the route, as initially determined at the time the report was prepared, is to be at the centre of the line shown on maps PSM 4a to PSM 4e as the proposed route of the trail.
- 4.2.15 If at any time in the future any part of a route section upon which roll-back has been specified needs, in Natural England's view, to change in order for the overall route to remain viable, the new route for the part in question will be determined by Natural England without further reference to the Secretary of State. This will be done in accordance with the criteria and procedures described under the title 'Roll-back' in part 7 of the Overview and section 4.10 of the Coastal Access Scheme. If this happens, the new route will become the approved route for that section for the purposes of the Order which determines where coastal access rights apply.

Other future change:

4.2.16 At this point we do not foresee any other need for future changes to the access provisions that we have proposed within this report.

See parts 7 - 'Future changes' of the Overview for more information.

Establishment of the trail:

4.2.17 Below we summarise how our proposed route for the trail would be physically established to make it ready for public use before any new rights come into force.

Establishment works will only start on this length of coast once these proposals have been approved by the Secretary of State. The works may therefore either precede or follow the start of establishment works on other lengths of coast within the stretch, and detailed in their separate reports.

- 4.2.18 Our estimate of the capital costs for physical establishment of the trail on the proposed route is £6,750 and is informed by:
 - information already held by Cornwall Council, Cormac and National Trust, in relation to the management of the existing South West Coast Path;
 - the conclusions of our deliberations in relation to potential impacts on the environment; and

- information gathered while visiting affected land and talking to the people who own and manage it about the options for the route.
- 4.2.19 There are two main elements to the overall cost:
 - New signs would be needed on route sections where the proposed route differs from that of the existing South West Coast Path
 - New surfaces and access furniture would be required on route some sections where the proposed route differs from that of the existing South West Coast Path:
 - New steps, vegetation clearance and surfacing in places along the new route at Halzephron.

Table 1 shows our estimate of the capital cost for each of the main elements of physical establishment described above.

4.2.20 Once the Secretary of State's decision on our report has been notified, and further to our conversations with land managers during the route planning stage, Cornwall Council will liaise with affected land owners and occupiers about relevant aspects of the design, installation and maintenance of the new signs and infrastructure that are needed on their land. Prior to works being carried out on the ground, all necessary permissions, authorisations and consents will be obtained. All such works would conform to the published standards for National Trails and the other criteria described in our Coastal Access Scheme.

Maintenance of the trail:

- 4.2.21 Because the trail on this length of coast will form part of the National Trail being created around the whole coast of England called the England Coast Path, we envisage that it will be maintained to the same high quality standards as other National Trails in England (see The New Deal; Management of National Trails in England from April 2013: details at Annex A of the Overview).
- 4.2.22 We estimate that the annual cost to maintain the trail will be £5734.23 (exclusive of any VAT payable). In developing this estimate we have taken account of the formula used to calculate Natural England's contribution to the maintenance of other National Trails.

Part 4.3: Proposals Tables

4.3.1 Details for sections that follow the existing South West Coast Path: Maps PSM 4a to PSM 4e, Loe Bar to Mullion Cove

Key notes on table:

- 1. Column 3 'No' means no roll-back is proposed for this route section. 'Yes normal' means roll-back is proposed and is likely to follow the current feature (e.g. cliff edge/beach) for the foreseeable future as any coastal change occurs.
- 2. Column 3 'Yes see table 4.3.4' means roll-back is proposed, but refer to that table below about our likely approach to implementing it for this route section. This is because a more complex situation exists in this case and consideration must be given to how roll-back may happen in relation to excepted land, a protected site etc.
- 3. Column 4a Certain coastal land types are included automatically in the coastal margin where they fall landward of the trail if they touch it at some point. The relevant land type (foreshore, cliff, bank, barrier, dune, beach, flat or section 15 land see Glossary) is shown in this column where appropriate. "No" means none present on this route section.
- 4. Columns 4b and 4c Any entry in these columns means we are proposing to align the landward boundary of the coastal margin on this route section with the physical feature(s) shown in 4b, for the reason in 4c. No text here means that for this route section the landward edge of the margin would be that of the trail itself or if any default coastal land type is shown in 4a, that would be its landward boundary instead.

Part 3 of the Overview to the report explains where the landward boundary of the coastal margin falls by default. Our proposals include any suggested variation of this default boundary. The purple wash on the map indicates where as a result of our proposals the coastal margin would extend significantly to the landward side of the proposed route of the trail. The coastal margin may include some areas where coastal access rights do not apply, either seaward or landward of the proposed route of the trail: the Overview explains more about this. The landward boundary of the coastal margin may in due course move inland, if the trail rolls back under proposals in this report to respond to coastal change.





Map PSM 4a: Loe Bar to Gunwalloe quarry






Map PSM 4b: Gunwalloe quarry to Halzephron Cliff


