Report MNQ 10: Constantine Bay to Mawgan Porth

Part 10.1: Introduction

Start Point:	Constantine Bay (grid reference: SW 8585 7455)
End Point:	Mawgan Porth (grid reference: SW 8494 6718)
Relevant Maps:	MNQ 10a to MNQ 10e

- 10.1.1 This is one of a series of linked but legally separate reports published by Natural England under section 51 of the National Parks and Access to the Countryside Act 1949, which make proposals to the Secretary of State for improved public access along and to this stretch of coast between Marsland Mouth and Newquay.
- 10.1.2 This report covers length MNQ 10 of the stretch, which is the coast between Constantine Bay and Mawgan Porth. It makes free-standing statutory proposals for this part of the stretch, and seeks approval for them by the Secretary of State in their own right under section 52 of the National Parks and Access to the Countryside Act 1949.
- 10.1.3 The report explains how we propose to implement the England Coast Path ("the trail") on this part of the stretch, and details the likely consequences in terms of the wider 'Coastal Margin' that will be created if our proposals are approved by the Secretary of State. Our report also sets out:
 - any proposals we think are necessary for restricting or excluding coastal access rights to address particular issues, in line with the powers in the legislation; and
 - any proposed powers for the trail to be capable of being relocated on particular sections ("roll-back"), if this proves necessary in the future because of coastal change.
- 10.1.4 There is also a single Overview document for the whole of this stretch of coast, explaining common principles and background. This and the other individual reports relating to the stretch should be read in conjunction with the Overview. The Overview explains, among other things, how we have considered any potential environmental impacts of improving public access to this part of the coast, and this report, and other separately published assessments we refer to, then provides more detail on these aspects where appropriate.

Part 10.2: Proposals Narrative

The trail:

- 10.2.1 Follows the existing South West Coast Path as currently walked and managed along most of this length. See maps MNQ 10a to MNQ 10e and table 10.3.1 below for more details.
- 10.2.2 Differs from the existing South West Coast Path At Porthcothan Beach (route sections MNQ-10-S048 and MNQ-10-S049). This new route traverses the beach, in front of the dunes, to link up with the trail on the public footpath on the southern side of Porthcothan Bay. See map MNQ 10b and table 10.3.2 below for more details.
- 10.2.3 Is aligned on the beach at Treyarnon (route sections MNQ-10-S010 and MNQ-10-S011), at Porthcothan (route sections MNQ-10-S048 and MNQ-10-S049) and at Mawgan Porth (route sections MNQ-10-S111 and MNQ-10-S112). See maps MNQ 10a, MNQ 10b and MNQ 10e, respectively, and tables 10.3.1 and 10.3.2 below for more details.
- 10.2.4 Generally follows the coastline closely over this length and maintains good views of the sea.

The South West Coast Path

10.2.5 The South West Coast Path generally follows the coast over this length and for the most part we propose adopting the walked line of this route as the line of the England Coast Path. However, there are places where we have proposed improvements to the existing route line, and furthermore there may be places where the walked line differs slightly from the route originally approved by the Secretary of State, as the path has evolved over time to cope with coastal erosion and other processes. In both situations, as explained at part 6a of the Overview, assuming these proposals are approved, we intend to use a separate variation report to the Secretary of State to change the route of the existing national trail to reflect the approved line of the England Coast Path insofar as the two are different.

Protection of the environment:

In this part of the report, we explain how we have taken account of environmental protection objectives in developing our proposals for improved coastal access.

10.2.6 The following designated sites affect this length of coast:

- Padstow Bay and Surrounds Marine Conservation Zone (MCZ)
- Bedruthan Steps and Park Head Site of Special Scientific Interest (SSSI) for its geological and wildlife interest
- Three promontory forts south of Trethias Island Scheduled Monument (SM)
- Round barrow cemetery at Park Head (SM)
- Redcliff Castle, later prehistoric cliff castle 550m south west of Bedruthan (SM)
- Two round barrows 440m and 510m north west of High Cove Farm (SM)

Maps C and D in the Overview show the extent of designated areas along this section of coast.

- 10.2.7 We consider that the coastal environment, including features of the sites listed above, along this length of coast is unlikely to be sensitive to the improvements to coastal access envisaged and that no special measures are needed in respect of our proposals.
- 10.2.8 Natural England is satisfied that the proposals for coastal access in this report are made in accordance with relevant environmental protection legislation. In respect of cultural heritage, we have taken advice from Historic England and others before confirming this conclusion. For more information about how we came to this conclusion in respect of the natural environment; see the following assessments of the access proposals that we have published separately:
 - A Habitats Regulations Assessment relating to any potential impact on the conservation objectives of European sites.
 - Our Nature Conservation Assessment, in which we document our conclusions in relation to other potential impacts on nature conservation.

Part 6b of the Overview includes some contextual information about protecting the environment along this length of coast.

Accessibility:

- 10.2.9 There are few artificial barriers to accessibility on the proposed route. However, the natural coastal terrain is often challenging for people with reduced mobility and this is the case on sections of our proposed route because:
 - The trail would follow an uneven grass or bare soil path along the cliff top;
 - The trail would follow a section of sandy beach at Porthcothan;
 - There are steep gradients where it would be necessary to ascend/descend steps.
- 10.2.10 North of Treyarnon Bay (route section MNQ-10-S003) a stone stile will be replaced by a pedestrian gate to facilitate access by less mobile users (see map MNQ 10a).
- 10.2.11 At Porthcothan Beach (route section MNQ-10-S050) the steps leading from the beach will be improved to make this area more accessible (see map MNQ 10b).
- 10.2.12 At Porthcothan Bay (route section MNQ-10-S057) the drainage and path surface will be improved to make this area more accessible and less hazardous in wet conditions.

We envisage these works happening before the new access rights come into force as part of the physical establishment work described below.

See part 6a of the Overview - 'Recreational issues' - for more information.

Where we have proposed exercising statutory discretions:

10.2.13 **Landward boundary of the coastal margin:** We have used our discretion on some sections of the route to map the landward extent of the coastal margin to an adjacent physical boundary such as a fence line, pavement or track to make the extent of the new access rights clearer. See table 10.3.1 below.

10.2.14 In some places we have used our discretion to propose the inclusion of additional, more extensive landward areas within the coastal margin, to secure or enhance public enjoyment of this part of the coast. The owner of this land is content for us to propose this. See maps MNQ 10b to MNQ 10d and table 10.3.1 below for more details.

10.2.15 The Proposals Tables show where we are proposing to alter the default landward boundary of the coastal margin. These proposals are set out in columns 4b and 4c of table 10.3.1 and columns 5b and 5c of table 10.3.2. Where these columns are left blank, we are making no such proposals, so the default landward boundary applies. See the note relating to these columns above tables 10.3.1 and 10.3.2 explaining what this means in practice.

See also part 3 of the Overview - 'Understanding the proposals and accompanying maps', for a more detailed explanation of the default extent of the coastal margin and how we may use our discretion to adjust the margin, either to add land or to provide clarity.

10.2.16 **Coastal erosion:** Natural England is able to propose that the route of the trail would be able to change in the future, without further approval from the Secretary of State, in response to coastal change. This would happen in accordance with the criteria and procedures for 'roll-back' set out in part 7 of the Overview.

Natural England may only propose the use of this roll-back power:

- as a result of coastal erosion or other geomorphological processes or encroachment by the sea, or
- in order to link with other parts of the route that need to roll back in direct response to such changes.

10.2.17 Column 3 of table 10.3.1 and column 4 of table 10.3.2 indicate where roll-back has been proposed in relation to a route section. Where this is the case, the route, as initially determined at the time the report was prepared, is to be at the centre of the line shown on maps MNQ 10a to MNQ 10e as the proposed route of the trail.

10.2.18 If at any time in the future any part of a route section upon which roll-back has been specified needs, in Natural England's view, to change in order for the overall route to remain viable, the new route for the part in question will be determined by Natural England without further reference to the Secretary of State. This will be done in accordance with the criteria and procedures described under the title 'Roll-back' in part 7 of the Overview and section 4.10 of the Coastal Access Scheme. If this happens, the new route will become the approved route for that section for the purposes of the Order which determines where coastal access rights apply.

Other future change:

10.2.19 At this point we do not foresee any other need for future changes to the access provisions that we have proposed within this report.

See parts 7 - 'Future changes' of the Overview for more information.

Establishment of the trail:

10.2.20 Below we summarise how our proposed route for the trail would be physically established to make it ready for public use before any new rights come into force.

Establishment works will only start on this length of coast once these proposals have been approved by the Secretary of State. The works may therefore either precede or follow the start of establishment works on other lengths of coast within the stretch, and detailed in their separate reports.

10.2.21 Our estimate of the capital costs for physical establishment of the trail on the proposed route is £6,565 and is informed by:

- information already held by the access authority (Cornwall Council) in relation to the management of the existing South West Coast Path;
- the conclusions of our deliberations in relation to potential impacts on the environment; and
- information gathered while visiting affected land and talking to the people who own and manage it about the options for the route.

10.2.22 There are two main elements to the overall cost in addition to project management:

- A number of new signs would be needed on the trail, in particular on route sections where the proposed route differs from that of the existing South West Coast Path.
- The surfaces and access furniture of the existing paths on the proposed route are generally of a suitable standard for the trail, but there are some places where drainage improvements, path resurfacing and replacement steps would enhance the convenience of the trail (see points 10.2.10 to 10.2.12 above). The significant items of establishment works are shown on the relevant maps accompanying this report.

Table 1 shows our estimate of the capital cost for each of the main elements of physical establishment described above.

10.2.23 Once the Secretary of State's decision on our report has been notified, and further to our conversations with land managers during the route planning stage, Cornwall Council will liaise with affected land owners and occupiers about relevant aspects of the design, installation and maintenance of the new signs and infrastructure that are needed on their land. Prior to works being carried out on the ground, all necessary permissions, authorisations and consents will be obtained. All such works would conform to the published standards for National Trails and the other criteria described in our Coastal Access Scheme.

Maintenance of the trail:

10.2.24 Because the trail on this length of coast will form part of the National Trail being created around the whole coast of England called the England Coast Path, we envisage that it will be maintained to the

same high quality standards as other National Trails in England (see The New Deal; Management of National Trails in England from April 2013: details at Annex A of the Overview).

10.2.25 We estimate that the annual cost to maintain the trail will be £7,464 (exclusive of any VAT payable). In developing this estimate we have taken account of the formula used to calculate Natural England's contribution to the maintenance of other National Trails.

Key notes on table:

- 1. Column 2 an asterisk (*) against the route section number means see also table 10.3.4: Other options considered.
- 2. Column 3 'Yes normal' means roll-back is proposed and is likely to follow the current feature (e.g. cliff edge/beach) for the foreseeable future as any coastal change occurs.
- 3. Column 3 'Yes see table 10.3.3' means roll-back is proposed, but refer to that table below about our likely approach to implementing it for this route section. This is because a more complex situation exists in this case and consideration must be given to how roll-back may happen in relation to excepted land, a protected site etc.
- 4. Column 4a Certain coastal land types are included automatically in the coastal margin where they fall landward of the trail if they touch it at some point. The relevant land type (foreshore, cliff, bank, barrier, dune, beach, flat or section 15 land see Glossary) is shown in this column where appropriate. "No" means none present on this route section.
- 5. Columns 4b and 4c Any entry in these columns means we are proposing to align the landward boundary of the coastal margin on this route section with the physical feature(s) shown in 4b, for the reason in 4c. No text here means that for this route section the landward edge of the margin would be that of the trail itself or if any default coastal land type is shown in 4a, that would be its landward boundary instead.

Part 3 of the Overview to the report explains where the landward boundary of the coastal margin falls by default. Our proposals include any suggested variation of this default boundary. The purple wash on the map indicates where as a result of our proposals the coastal margin would extend significantly to the landward side of the proposed route of the trail. The coastal margin may include some areas where coastal occess rights do not apply, either seaward or landward of the proposed route of the trail: the Overview explains more about this. The landward boundary of the coastal margin may in due course move inland, if the trail rolls back under proposals in this report to respond to coastal change.

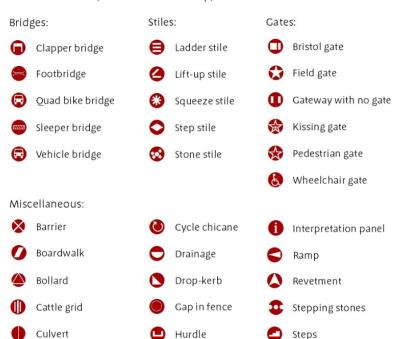






Map MNQ 10b: Minnows Cove to Porth Mear
