

Further education and skills release: November 2019 underlying data

Metadata specification

Description

This document describes the data included in the 'Further education and skills: November 2019' National Statistics release's underlying data file. This data is released under the terms of the [Open Government License](#). It is provided to allow users to interrogate the data themselves.

The underlying data files contain apprenticeship starts and achievements and Further Education and Skills participation figures in England, broken down by learner characteristics (e.g. age, gender, ethnicity group) and subject characteristics (e.g. sector subject area, level, framework and standard name).

It provides information on the data sources, their coverage and quality as well as explaining methodology used in producing the data.
