Introductory note

This introductory note does not form a part of the notice

Under the Environmental Permitting (England & Wales) Regulations 2016 (schedule 5, part 1, paragraph 19) a variation may comprise a consolidated permit reflecting the variations and a notice specifying the variations included in that consolidated permit.

Schedule 1 of the notice specifies the conditions that have been varied and schedule 2 comprises a consolidated permit which reflects the variations being made. All the conditions of the permit have been varied and are subject to the right of appeal.

This application has varied the permit from being a waste regime permit to a standard rule SR2009 No 2 installation permit.

The installation produces agricultural fertilizer. The process will involve the mixing of End of Waste Meat and Bone Meal Ash (MBMA) with a number of non-waste materials (Inc. Water, Sulphuric Acid and Calcium Oxide) to produce an exothermic reaction allowing the waste and non-waste materials to react within a mixer. The resultant physico-chemical reaction allows the formulation of the granular fertiliser, which self-cures due to the heat of reaction. The capacity is of circa 80 t/day of MBMA and other non-waste raw material volumes less than 10 t/day.

The installation is located at Grid Reference NZ 56872 21583 within the Wilton International Site. The site is situated approximately 8km northeast of Middlesbrough.

The schedules specify the changes made to the permit.
