Note 1

Age 24 or 2 years from date of Standard A2 test pass. Tricycle restriction code 79 (tri)/79(03).

Note 2

Age 16 if you are getting the mobility component of Personal Independence Payment (PIP) or Adult Disability Payment (ADP) at the enhanced rate, the mobility component of Child Disability Payment (CDP) at the higher rate or have applied for PIP having previously received the mobility component of Disability Living Allowance (DLA) at the higher rate. If your circumstances change while you are 16 and you lose your qualifying benefit or it is re-assessed and awarded at a lower rate, you are required to notify DVLA, as this may effect your entitlement to drive.

Note 3

You can drive at age 17 if you are a member of the armed forces. You can drive at 18 if one of the following apply:

- you passed your driving test and Driver Certificate of Professional Competence (Driver CPC) initial qualification
- you are learning to drive or taking a driving test for this category or Driver CPC initial qualification
- you are taking a national vocational training course to get a Driver CPC initial qualification
- you had your driving licence before 10 September 2009 you must take the driver CPC periodic training within 5 years of this date

Note 4

You can drive at age 17 if you are a member of the armed forces. You can drive these vehicles at age 18 if one of the following apply.

- You are either learning to take your Passenger Carrying Vehicle (PCV) test or get your Driver Certificate of Professional Competence (CPC)
- (2) If you have passed a PCV driving test and Driver CPC initial qualification, you can drive if:
 - carrying passengers on a regular service where the route does not exceed 31 miles
 - not engaged in the carriage of passengers
 - driving a vehicle of a class included in sub-category D1
 - you do not drive a bus or minibus abroad
- (3) Since 10 September 2008, drivers passing a PCV test and driving under a bus operator's licence, minibus permit, or community bus permit can drive if:
 - carrying passengers on a regular service where the route does not exceed 31 miles
 - not engaged in the carriage of passengers

- driving a vehicle of a class included in sub-category D1
- you do not drive a bus or minibus abroad

You can drive at age 20 after passing a PCV driving test and Driver CPC initial qualification.

Age 21 for categories D and DE if:

- the vehicle is being used by the fire service or for maintaining public order
- undergoing road tests for repair or maintenance purposes
- if you were entitled to drive the vehicle before 19 January 2013

Note 5

If you passed your test for category B or B automatic before 1 January 1997, your licence will already show entitlement to C1, C1E (8.25 tonnes), D1 and D1E (not for hire or reward).

Note 6

National category only.

Note 7

At 16, you can drive tractors less than 2.45m wide. It must only pull trailers less than 2.45m wide with 2 wheels or 4 wheels that are close-coupled.

Note 8

At 17, you can drive small road rollers with metal or hard rollers. They must not be steam powered, weigh more than 11.69 tonnes or be made for carrying loads.

Note 9

You can drive at 17 if the MAM of the tracked vehicle is no more than 3,500kg.

Note 10

You can ride or drive at age 17 if you are a member of the armed forces.

Note 11

An exemption exists for the holder of category B to drive large motor tricycles in category A if they are over 21 years of age.

Important notes

Α

Northern Ireland licence holders only

As a result of a change in legislation, from April 2009, Northern Ireland licence holders no longer have to register to take advantage of the fixed penalty system.



Registering your licence

The law requires all those who live in GB and drive buses with 9 or more passenger seats, or vehicles weighing more than 3.5 tonnes, to be registered with the Driver and Vehicle Licensing Agency (DVLA).

You are required by law to do this within 12 months of you taking up residence.

Drivers who exchange their licence in GB are automatically registered.

If your licence is lost or stolen and you are unable to get a duplicate from the country it was issued, you can apply for a GB licence from DVLA.

Note: As a result of a change in legislation, from April 2009, European Union (EU) or European Economic Area (EEA) licence holders are no longer required to register their licence to accept a fixed penalty.

How to register

Please fill in this form and send it, together with all parts of your national driving licence, to DVLA, Swansea, SA99 1BH. If you are an EU or EEA licence holder, you will be issued a letter of registration document.

Driving licence rules in GB

As the holder of a licence issued by an EU member state or by Iceland, Liechtenstein or Norway (see note D), provided your licence remains valid, you can drive in GB until age 70 or for 3 years after becoming resident – whichever is the longer period. Expired licences are acceptable to exchange for a GB licence.

The rules for holding a GB driving licence are almost certainly different from those in the country in which your licence was issued. The rules in GB for medical, driving conduct, road safety and driving licence renewal are those which you must observe if you live here.

Bus or Lorry drivers

When you are 45 years old or over, you will have to renew your licence at least every 5 years – 65-year-olds have to renew annually – subject to passing a medical examination by your doctor. Once your EU or EEA licence expires or you reach the above age limits you must apply to DVLA for a GB licence.

Note: If you pass a driving test in GB, you will be issued with a licence valid for a maximum of 5 years. Drivers under 45 must fill in the medical questions on the D2 application form or the renewal reminder form. Drivers over 45 will also need to supply a D4 medical examination report at each renewal and fill in the medical questions.



Relevant countries

You can register with us if your EU licence was obtained by exchanging a licence from one of the countries listed below. If your EU licence was obtained by exchanging from a country not listed below, you will not be able to register. However, you will still be able to drive Category B vehicles in the UK on your licence for up to a year, after which time you will have to apply for a GB licence.

These are the relevant countries:

Austria, Belgium, Bulgaria, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Republic of Cyprus, Romania, Slovakia, Slovenia, Spain and Sweden.

Medical conditions

If you have ever had or presently suffer from any of the following conditions, you must tell us immediately. You can do this by writing to Drivers Medical Group, DVLA, Swansea, SA99 1TU with the nature of your condition.

Alternatively, you can tell us by phone by calling 0300 790 6806.

- Diabetes controlled by insulin and/or you have had 2 or more episodes of severe hypoglycaemia where you required help from another person in the past 12 months
- Epilepsy, seizure(s) or blackout(s)
- Eye condition affecting both eyes, or the remaining eye if you only have one eye. (Not including colour blindness or short or long sight)
- Visual field issued caused by any condition (apart from wearing glasses or corrective lenses)
- Stroke with any symptoms lasting longer than one month
- Brain surgery or severe head injury involving in-patient treatment
- Brain tumour
- Cardiac pacemaker
- Cardiac defibrillator (ICD)
- Dizziness repeated sudden disabling episodes
- Chronic neurological condition such as; Multiple sclerosis, Motor neurone disease or Huntington's disease
- Serious memory problems
- · Persistent drug misuse or dependence
- Persistent alcohol misuse or dependence
- Parkinson's disease
- Narcolepsy or any condition causing excessive sleepiness such as Obstructive Sleep Apnoea Syndrome
- Persisting limb problem which needs to be restricted to certain types of vehicles or those with adopted controls
- Severe learning disability

We will be able to process your application more quickly if you complete and include the relevant questionnaire which you can download from www.gov.uk/driving-medical-conditions

You must tell us immediately about a relevant condition or a condition getting worse. You could have to pay a fine of up to $\mathfrak{L}1000$ if you do not.

Your conduct – Large goods and passenger carrying vehicles

In all cases of questionable conduct, the Traffic Commissioner for the area in which you live will decide whether to grant your entitlement to drive large goods or passenger carrying vehicles.

Driving conduct

You must tell us if you have any convictions for breaking the rules about:

- drivers' hours
- the roadworthiness of vehicles
- drivers' records
- overloading of vehicles

Do not tell us about any convictions if they were more than 4 years ago.

All endorsements on your licence will be taken into account when it is decided whether to give you entitlement to drive in GB. We will not give you entitlement to drive if you are disqualified from driving.

Conduct not related to driving

Passenger carrying vehicle (PCV) drivers only

If you drive a minibus or bus, you must let us know about any court convictions you have had – even if they are not to do with driving, unless they have run out under the Rehabilitation of Offenders Act 1974.
