# Summary of consultation

The Ministry of Housing, Communities and Local Government (MHCLG) is currently looking at changing the revisions policy for the net additional dwellings statistics.

The current revisions policy is to revise the figures every ten years when the latest census estimates of dwelling stock are made available. This means that currently any updates to the figures provided by local authorities are not picked up in the estimates until the census data are made available.

The department is proposing to change this revisions policy to allow local authorities to revise previous year's figures. This will bring the revisions policy in line with the departments other housing and planning statistical releases and will have the effect of making the figures more accurate in between census periods.

The department is not proposing any changes to the definitions, underlying data or outputs. The change is only to allow the timelier revision of previously submitted data.

# Scope of the consultation

Topic of this consultation:	This consultation seeks views on the proposed changing of the revisions policy for the Housing supply; net additional dwellings statistics release.
Scope of this consultation:	We are considering how best to meet the needs of users in improving the quality of these statistics.
	Housing supply; net additional dwellings statistics is the department's main officially published measure of housing supply and currently no revisions to these figures are permitted after they have been published, except every ten years at the time of the new census. We are proposing to change this policy to have more frequent annual revisions to this release which will improve the accuracy of previous years estimates of housing supply.
Geographical scope:	These proposals relate to statistics for England only.
Impact	An impact assessment is not required as this is a technical
Assessment:	consultation relating to the Ministry's statistical activity.

# Housing supply; net additional dwellings statistics

## Introduction

 This document invites comments on the Ministry of Housing, Communities and Local Government (MHCLG) proposals for the revisions policy of the Housing supply; net additional dwellings statistics.

- 2. The Housing supply; net additional dwellings statistics is badged as National Statistics with its bulletin published annually in November. It reports the most accurate estimates for new housing supply in England.
- 3. MHCLG has a statutory duty, in accordance with the Statistics and Registration Act 2007, to ensure its statistics meets user needs and engage users on changes to the department's statistical output. This consultation meets the requirements for National Statistics to consult its users where major changes are proposed.
- 4. We review here the current revisions policy and propose how this could be improved to better meet user needs.

#### The current revisions policy

- The policy has been developed in accordance with the UK Statistics Authority Code of Practice for Statistics and been in existence since this statistics release began being published in the early 2000s.
- 6. There are two types of revisions that the current policy covers:

**Non-Scheduled Revisions** Where a substantial error has occurred as a result of the compilation, imputation or dissemination process, the statistical release, live tables and other accompanying releases will be updated with a correction notice as soon as is practical.

**Scheduled Revisions** Local authorities may not revise the data they supply for these statistics after the original deadline for submission as this is an annual series with a relatively long data collection period. These statistics are compared against the census on its release every ten years to ensure that the sum of net additions over that period matches the difference between the latest census dwelling count and the previous one. The net additions figures are then adjusted, with any difference spread evenly across the ten years since the previous census.

- 7. The Non-Scheduled revisions policy is designed to cover instances where there has been an unexpected error in the technical processing of the data made by MHCLG statisticians after the data has been submitted by local authorities and validated. There are no plans to change this part of the revisions policy
- 8. The scheduled revisions policy does not allow for any regular revisions other than when figures are updated once every ten years to match the latest census figures. The effect of this is that if there are any updates to the local authority figures then they will not be updated for up to ten years when they are adjusted to the latest census data is available. The proposal in this consultation is to update the scheduled revisions policy.

### Meeting user needs

- User groups of the statistic are varied including: MHCLG and other government departments and agencies, local government, local government associations, academics, media, and community and campaign groups, as well as interested members of the public.
- 10. Housing supply; net additional dwellings statistics are designed to provide these users the most accurate estimates of housing supply in local authority areas. It is not proposed that the underlying data definitions or any published products change, just that the figures are updated and revised more frequently.

#### Proposed changes

- 11. The Housing supply; net additional dwellings statistics release includes the most accurate timely estimate of housing supply in England. Therefore, ensuring the statistics are as accurate and robust as possible is important. The statistics already have National Statistics status, meaning they meet the highest standards of statistics according to the UKSA's Code of Practice for Statistics. This change in the scheduled revisions policy is designed to further improve the statistics by increasing the accuracy and timeliness of estimates.
- 12. Changing the scheduled revisions policy will standardise the approach to revisions in the departments statistical output. Having revisions to the numbers only made every ten years is different to with other housing and planning statistical releases which allow revisions to previous periods figures when publishing the latest data.
- 13. Changing the revisions policy will have no effect on the methodology used to produce the latest years figures, they will continue to be submitted by local authorities and processed in the same way as they are now. Further details of the current process are included in the latest statistical release
- 14. The department is proposing to start allowing annual revisions, beginning when the 2019-20 figures are published in November 2020. This would be to the previous two year's published figures, allowing local authorities to initially update their figures over a longer period. Then in future years the revisions period would cover the previous year's figures only.
- 15. The proposed change to the scheduled revisions policy is to come into effect so that revisions will be made for the first time in the November 2020 release.

How the new revisions policy will affect numbers if implemented in November 2020:

And then, on an on-going basis, each year authorities would continue to be able to submit revisions to their previous year's figures.

- 16. Revisions would also still take place every ten years at the time of the census though the benefit of allowing annual revisions would be that these adjustments to the census would be expected to be much smaller. The last census revisions saw 16,190 added to each year from 2006-07 to 2010-11.
- 17. This proposed change to the scheduled revisions policy would also align with the period covered by the Housing Delivery Test. The Housing Delivery Test uses adjusted net additions figures as part of an assessment of housing supply delivery in local authorities. Allowing revisions to net additions would also allow local authorities to provide revisions which would flow through to future years Housing Delivery Test calculations.
