

# Further education and skills: January 2020 underlying data

## Metadata specification

### Description

This document describes the data included in the 'Further education and skills: January 2020' National Statistics release's underlying data files. This data is released under the terms of the [Open Government License](#). It is provided to allow users to interrogate the data themselves.

The underlying data files contain apprenticeship starts and achievements, and Further Education and Skills participation and achievements figures in England; broken down by learner characteristics (e.g. age, gender, ethnicity group) and subject characteristics (e.g. sector subject area, level, framework and standard name).

The quality and methodology document published alongside the [Further education and skills: March 2019](#) statistics publication should be referenced alongside this data. It provides information on the data sources, their coverage and quality as well as explaining methodology used in producing the data.
