### **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information about bovine TB in Cheshire which we received clarity for on 22 November 2018. Your request has been handled under the both the Freedom of Information Act 2000 (FOI) and the Environmental Regulation Information 2004(EIR).

The information you requested and our response is detailed below:

• "The number of badgers culled in Cheshire in the years 2017 and 2018 so far

The information that you have requested for **2017** is available via the following link:

Bovine TB: authorisation for badger control in 2017 - GOV.UK

As the information you have requested is already publicly available and easily accessible to you in another form or format, regulation 6(1)(b) of the EIRs exempts Defra from providing a copy of the information with this response to your request.

The information that you have requested for 2018 is being withheld at present because it falls under the exception in regulation 12(4)(d) of the EIRs.

Regulation 12(4)(d) of the EIRs relates to material that is still in the course of completion, unfinished documents and incomplete data. In respect of this information Defra teams are still in the process of finalising the work. It is APHA/Defra's intention to publish the information as soon as possible.

In applying this exception, we have had to balance the public interest in withholding the information against the public interest in disclosure. APHA recognises that there is a public interest in understanding the work of Government and the accountability and transparency around the badger culling.

However, releasing information before all of the data has been collated and verified and reports have been fully reviewed and finalised would likely mislead the public, if they

have to be revised as part of the process. This includes establishing whether any further work is necessary before drawing the project to a close.

This would not be in the public interest. Moreover, as mentioned above, APHA/Defra will be publishing the information in due course and so there would not be any further public interest to be served by early disclosure of the information which will be available to all interested parties in due course.

Therefore, we have concluded that in all the circumstances of the case, the information should be withheld.

• The number of badgers culled which were found to have Bovine TB in the years 2017 and 2018 so far

APHA can confirm that they did not conduct any tests to detect M.bovis during 2017 and it is too soon for results from the limited work that has been done in 2018. For your information not ALL culled badgers are tested.

• The number of cases of Bovine TB in cattle in Cheshire in the years 2017 and 2018 so far"
