Information on the HIF Forward Funding Bid Process AND what Infrastructure facilities should be provided within a new 'Garden Communities' Development

Response

We can confirm that we do hold some of the requested information. We will address each of your points in turn.

Information on the HIF Forward Funding Bid Process

We are able to inform you that we do hold the information that you have requested. However, we rely on section 21, exemption where information is available to the applicant elsewhere.

21 - Information accessible to applicant by other means.

(1) Information which is reasonably accessible to the applicant otherwise than under section 1 is exempt information.

(2) For the purposes of subsection (1)—

(a) information may be reasonably accessible to the applicant even though it is accessible only on payment, and

(b) information is to be taken to be reasonably accessible to the applicant if it is information which the public authority or any other person is obliged by or under any enactment to communicate (otherwise than by making the information available for inspection) to members of the public on request, whether free of charge or on payment.

(3) For the purposes of subsection (1), information which is held by a public authority and does not fall within subsection (2)(b) is not to be regarded as reasonably accessible to the applicant merely because the information is available from the public authority itself on request, unless the information is made available

What Infrastructure facilities should be provided within a new 'Garden Communities' Development

I am able to inform you that Homes England does not hold the information detailed in your request. This is because there is no definitive list of what infrastructure facilities should be provided in a garden community, and much will depend on the context and scale of the proposed community.

In order to conclude that no recorded information is held, we have searched with our Garden Communities Team, who would have the requested information if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.
