Date of decision: 16 March 2020

Determination

In accordance with section 88E of the School Standards and Framework Act 1998, I do not approve the proposed variation to the admission arrangements determined by Leicester City Council for Sandfield Close Primary School for September 2020.

The referral

- 1. Leicester City Council (the local authority) has referred a proposal for a variation to the admission arrangements for September 2020 for Sandfield Close Primary School (the school), to the Office of the Schools Adjudicator. The school is a community school for children aged 4 to 11 in Leicester.
- 2. The proposed variation is that the published admission number (PAN) be reduced from 60 to 30.

Jurisdiction

3. The referral was made to me in accordance with section 88E of the School Standards and Framework Act 1998 (the Act) which states that: "where an admission authority (a) have in accordance with section 88C determined the admission arrangements which are to apply for a particular school year, but (b) at any time before the end of that year consider that the arrangements should be varied in view of a major change in circumstances occurring since they were so determined, the authority must [except in a case where the authority's proposed variations fall within any description of variations prescribed for the purposes of this section] (a) refer their proposed variations".

4. I am satisfied that the proposed variation is within my jurisdiction.

Procedure

- 5. In considering this matter I have had regard to all relevant legislation, and the School Admissions Code (the Code).
- 6. The documents I have considered in reaching my decision include:
 - a. the referral from the local authority sent on 17 January 2020, supporting documents and further information provided at my request;
 - b. the determined arrangements for 2020 and the proposed variation to those arrangements;
 - c. a copy of the local authority's booklet for parents seeking admission to schools in the area in September 2020;
 - d. confirmation that the local authority has consulted the governing board of the school;
 - e. a map showing the location of the school and other relevant schools; and
 - f. a copy of the email dated 16 January 2020 notifying the appropriate bodies about the proposed variation.

The proposed variation

- 7. The local authority has applied for a reduction in the PAN at the school as "There has been a drop in the number of forecasted places for Sandfield Close Primary over recent years and this is impacting on the schools budget and resource situation."
- 8. Paragraph 3.6 of the Code requires that admission arrangements, once determined, may only be changed, that is varied, if there is a major change of circumstance or certain other limited and specified circumstances. I will consider below whether the variation requested is justified by the change in circumstances.
- 9. Paragraph 3.6 of the Code also requires that relevant parties be notified of a proposed variation. The local authority has provided me with a copy of its notification on the proposed variation and the list of schools and other bodies to which it was sent. I have seen confirmation from the school's governing board that it supports the request for the variation. I find that the appropriate procedures were followed.
- 10. However, I am concerned about the timing of this application to reduce the PAN at the school for admission in September 2020 as parents had to complete the application form and set out their preferences by 15 January 2020. The application was submitted to the OSA on 16 January 2020 and parents may not have been aware about the proposal to

reduce the number of places available and may indeed have changed their preferences if they had been aware. I shall explore the issue in more detail later in this determination. I will also explore the pattern of applications for the school and whether there will be sufficient places in the area if the places are removed. In the notification to relevant bodies, the local authority wrote "Our data shows that we will continue to have a sufficiency of places in the local area and as part of our school organisation duty, we will continue to monitor future trends, surplus capacity, birth rates and work with schools to make any required adjustments."

Consideration of proposed variation

- 11. The local authority has five Primary School Cluster Areas and the school is located in the North Planning area along with 20 other schools which admit to Reception Year (YR). The school is the only one in the planning area where a reduction in PAN is proposed.
- 12. In order to determine whether there would be sufficient places in the area I first looked at the places available in the planning area and put alongside that information, the number of children offered places on National Offer Day and the number of children on the school roll at the October census for YR.

13. It is clear from Table 4 that there is an overprovision of places in the area and I am satisfied that the local authority is able to meet its duty to provide sufficient places. I now consider the situation at the school itself and whether the reduction in places will impact on parental preferences. At the October census the school has had more than 30 pupils in YR over the last three years (40 in 2019 and 2018 and 41 in 2017). The local authority told me

that there have been 63 applications of which 31 are first preferences for admission in 2020. This means that at least one parent who would like their child to attend the school will not gain a place if the PAN is reduced. Moreover, some children for whom the school was a second or lower preference may have a higher priority than some first preference applicants. If they cannot be admitted to their higher preference schools, they will be offered places at Sandfield Close. All this means that it is possible that more than one parent will be disappointed if the PAN is reduced. On the other hand, some of those who are offered places in the first round of offers may move, opt for places at independent schools or, if the school is not their first preference, receive an offer in due course of a place at a preferred school.

- 14. The local authority told me "Sandfield Close Primary School will be able to manage their long term budget more efficiently as they will not have to employ additional resources to look after less full classes. Currently, Sandfield Primary have just under 50 empty places in KS [Key Stage]1." With an intake of 40 currently in YR, the school has to determine how to meet the requirements of the School Admissions (Infant Class Sizes) (England) Regulations 2012. The regulations mean that for infant aged children, there must not be more than 30 children to a single school teacher (except in limited circumstances). In addition, in a normal year of entry a school must admit all those who apply up to the PAN. With a PAN of 60 and 40 children in YR in October, the school would have to provide two teachers to teach them. A PAN of 30 would mean that the school could have one class for YR rather than two. As schools are funded primarily on the basis of pupil numbers, it would clearly be more financially efficient if the PAN was reduced to 30. However, I need to balance the financial impact of two smaller classes with meeting parental preference which may have been different if parents had been aware of the proposed reduction in places before they made their preferences.
- 15. I also take into account that where a PAN is reduced in the normal course of determining arrangements, there must be consultation before determination and there is scope for making an objection to the adjudicator once a lower PAN has been determined. By contrast, where a variation is sought there is no requirement for consultation and no possibility of objecting to the adjudicator. I know that in this case the local authority did seek the views of other schools in the area and the governing board of the school but that is not the same as a proper consultation and does nothing to replace the ability to object to the adjudicator. It is likely that the school will admit more than 30 pupils for admission in 2020 if the PAN remains at 60. Parental preferences may have changed if it was clear that there was a proposal to reduce places at the school but parents would not have known of the proposal in good time for their choices to be influenced. Taking account of all the information provided to me, I have decided that the proposed variation is not justified by the circumstances.
- 16. I note also that the local authority has determined a PAN of 60 for the school in 2021 as they did not undertake a consultation in time to make the amendment that it is seeking

through this application for a variation in 2020. The local authority can if it wishes propose a variation to the PAN for 2021.

Determination

17. In accordance with section 88E of the School Standards and Framework Act 1998, I do not approve the proposed variation to the admission arrangements determined by Leicester City Council for Sandfield Close Primary School for September 2020.
