INTRODUCTION

1. This memo gives guidance on the Social Security (Coronavirus) (Prisoners) Regulations which came into force on 8.4.20¹.

Note: The regulations cease to have effect at the end of the period of eight months beginning on 13.3.20².

2. The regulations make provision for individuals on temporary release from a prison in England and Wales for any reason access means tested benefits during the period of that release.

PRISONERS

3. The definition of a prisoner¹ includes a person who is on temporary release from prison. A prisoner generally has no entitlement to IS/JSA/ESA/SPC.

CHANGES

4. From 8.4.20 the reference to The Prison Act 1952 is removed from the definition of a prisoner in IS/JSA/ESA/SPC. That refers to prisoners temporarily released from a



prison in England or Wales and its removal lifts the restriction on entitlement to means tested benefits for those prisoners so released.

Note: Cases of doubt should be sent to DMA Leeds for advice.

5. Also, the presence of temporarily released prisoners in a household claiming means tested benefits will be taken into account in calculating entitlement, for example being included as a member of a claimant's household.
6. The claimant will still be required to meet the usual conditions of entitlement, including the availability requirements (see DMG 24185-24186).

Note: The provision¹ that a prisoner temporarily released is regarded as not available will not apply.

7. From 8.4.20 a member of a couple or polygamous marriage shall no longer be treated as not being a member of the household¹ where they are on temporary release (see DMG 22054).
