## **Update on MHCLG statistical publications in 2020-21**

Due to the coronavirus outbreak (COVID-19) there will be some changes to our regular statistical production. Much of the data used in MHCLG statistical publications are collected from local authorities and we are mindful of the additional pressures they are facing as a result of the outbreak. We initially reviewed the priority of all statistical collections due to launch before the end of June which resulted in some collections being minimised, deferred or cancelled to reduce the burden on authorities during the outbreak and to enable the Department to focus efforts on priority analysis and statistics. We have now reviewed all collections due launch until the end of August. Collections are beginning to return to normal timescales so there are fewer changes to the publication schedule going forward.

To date, and in a lesser extent going forwards, collection periods have been extended to give local authorities a greater amount of time to submit data and consequently the production of data series will need to be delayed, and in some cases, suspended.

The disruption caused by the outbreak could also affect the quality of some of our statistics, such as lower accuracy, or it could mean there is less detail available, such as fewer local breakdowns. Where this occurs, this will be reflected in the data quality statement included within each statistical release.

This document sets out all MHCLG statistical publications planned for 2020-21 and indicates decisions made so far. These are being made on a case by case basis, taking into account what information is currently relevant given the situation, with the three pillars of the Code of Practice for Statistics (Trustworthiness, Quality and Value) guiding our decisions. To date we have reviewed collections due to launch before the end of August. Note because of varying collection and production periods this will include some, but not all, publications originally due for release up until December 2020. The list will be updated as further reviews are undertaken.
