Summary of meeting - London Transition Board 22 July 2020, 1615-1745

1. Chairs' welcome and introduction (Mayor, SoS)

- 1.1 The Mayor of London welcomed Transition Board (TB) attendees and introduced the items to be discussed, including reopening London's Arts and Culture sector and Outbreak Control.
- 2. Situational Analysis: Overview of current position in London (Transition Management Group Chair)
- 2.1 The Transition Management Group (SCG) Chair provided an overview of the current situation in London, highlighting that infection rates are currently very low but warning against complacency.
- 2.2 The new governance structure was outlined; the Strategic Coordination Group has become the Transition Management Group, to provide a mechanism for escalating risks seen at a local level.
- 2.3 The Board discussed the reopening of the West End, and agreed on the importance of coordinated, confident and consistent messaging to build public confidence.
- 3. Update on Reopening London's Arts and Culture Sector
- 3.1 The Mayor invited the Chair of the Arts and Culture Strategy Group to update the Board on the status of arts and culture and on concerns expressed by the sector.
- 3.2 A discussion followed, covering topics such as the importance of the sector for tourism, London's economic recovery and how the UK compares to other countries globally.
- 3.3 The Board members were given an update on Tube usage by the Commissioner of TFL which highlighted ongoing work on cleanliness and full services being provided to enable social distancing.
 - 4. Update on Outbreak Control (Head of Health, GLA)
- 4.1 The Mayor invited the Head of Health at the GLA to inform the Board about work that has been ongoing to understand the impacts of Covid on the population and the measures in place to prevent outbreaks.
- 4.2 Discussion followed, with a focus on the importance of communication, strong local partnerships and testing to help to prevent and manage potential outbreaks. The Test

and Trace programme was identified as an important means of managing outbreaks and building public confidence.

5. Update on Strategy Groups

- 5.1 The Chair of the Business Reopening and Open Spaces Strategy Group confirmed the group's priorities as building confidence in use of the transport network; the need for ongoing business support; and continuing to open the public realm and high street space safely. There was, he said, an overarching theme of clarity of message over returning to work and leisure activities. He noted that the Strategy Group will present at next Board.
- 5.2 The Chair of the Education Strategy Group identified the group's priority as schools reopening safely in September. Education will also present at the next Board.
- 5.3 The Wellbeing work stream is being considered in collaboration with an organisation focused on improving the mental health and wellbeing of Londoners.
