## Marital Status Certificate for Marriage or same-sex Civil Partnership registration in Andorra

All applicants must complete every section of this form and send it together with photocopies of the relevant supporting documents either by email or by post to the British Consulate-General in Barcelona. Failure to fill in the application pack correctly may delay your application.

Please note you will need to attend an appointment at the British Consulate-General in Barcelona and we will contact you to arrange this on receipt of your application by post or email. On the day of your appointment you will need to bring with you all the original documents you previously sent us by email/post. You will be charged two consular fees: ([Fee 2ii](#)) for the consular certificate and a separate fee ([Fee 4](#)), for your declaration of marital status that the consulate will provide for you. Payment can be made in cash or by credit card (Visa/MasterCard) at the consulate on the day of the appointment.

### 3. FREQUENTLY ASKED QUESTIONS

1. Will the certificate be issued in English?
  - A. No, the certificate will be issued in Catalan so there will be no need for you to have it translated for the Andorran authorities.
  
2. What will I have to do at my appointment?
  - A. You need to bring all your original documents to your appointment so they can be checked by a consular officer. Failure to do so may result in the appointment being cancelled. You will then be asked to complete, sign and affirm/swear an affirmation/affidavit regarding your marital status. Your Marital Status Certificate will be prepared while you wait.
  
3. Does the consular certificate need to be legalised (i.e. with an apostille)?
  - A. No. The signature of the Consular Officer on the certificate is accredited in Andorra.
  
4. How long will it take to get my appointment?
  - A. It can take up to 5 working days to process an application before you will receive your invitation to make an appointment. Appointments are subject to staff availability.
  
5. What other documents do I need to get married/register a civil partnership in Andorra?
  - A. You must check with the local authority where you are getting married/registering a civil partnership in Andorra to confirm which documents you will need to get married/register a civil partnership and also whether the documents need to be translated and legalised for use in Andorra.
  
6. What is my marital status if I am divorced?
  - A. Divorced (i.e. you are not single)
  
7. What is my marital status if I have registered a Unió Estable de Parella in Andorra?
  - A. A Unió Estable de Parella registration can be described as registering a common-law relationship. This means you have registered your cohabitation with your partner in Andorra **without** getting legally married or registering a civil partnership. Under English law a **cohabitation registration does not change your marital status**. If you are in a cohabitation registration in Andorra and you are single/divorced/widowed or your previous civil partnership has been annulled or dissolved, this is the marital status you need to indicate in question no. 6 in our application form. **Unió Estable de Parella i.e. cohabitation registration in Andorra is not the equivalent of UK Civil Partnership.** Civil Partnership registration in the UK is available for same-sex partners only and is regulated by English law. You will need to contact the authorities in Andorra regarding the cancellation of your Unió Estable de Parella after marriage/civil partnership registration.
  
8. The name and/or surname of my mother on my birth certificate is different to her name and /or surname now. Which name do I write on the affirmation/affidavit which will be given to me to complete at the consulate?
  - A. You must write the name and surname of your mother in the affirmation/affidavit **as it appears on your birth certificate** regardless of whether it has changed at any point since your birth certificate was issued.
  
9. Does my Andorran marriage/civil partnership need to be registered in the UK?
  - A. No, it is not possible to register your marriage/civil partnership either in the UK or at a British Consulate.
