## 1. Welcome and introduction

1.1. Cllr Ian Courts (The Chair) welcomed attendees to the meeting and the apologies were listed.

#### 2. Minutes of 02 August 2019 meeting and action update

- 2.1. Sub Committee members agreed that the minutes of the previous meeting were an accurate record.
- 2.2. Action 1) Liz Grove (LG) confirmed that this action had been superseded by the update on the ESF National Reserve Pot.
- 2.3. Action 2) LG confirmed that a press release to promote the June 2019 call had been published and circulated to CLG.
- 2.4. Action 3) LG confirmed that this action had been superseded with the update on the ESF National Reserve Pot.
- 2.5. Action 4) It was agreed the possibility of moving unspent PA4 & PA6 allocation to the SUD allocation would be discussed during the MEIF update later in the agenda.

# 3. EAFRD Update

- 3.1. Jo Jury (JJ) summarised the EAFRD papers circulated prior to the meeting.
- 3.2. Round three of the Grant Programme was launched 04 November 2019 as part of an EAFRD National Reserve Fund and includes a tourism, business and food call. The Grant Programme has a £20k grant minimum giving opportunities for small businesses to apply. It was clarified that depending on the activity food businesses in urban areas were eligible with a £750k max grant. First stage expressions of interest have a 16

February 2020 deadline. The MA are working closely with adjoining LEP areas including Worcestershire LEP, Coventry and Warwickshire LEP and Stoke-on-Trent and Staffordshire LEP.

3.3. Members were encouraged to promote the calls to businesses. JJ clarified that applications are to be made online and the expressions of interest process is very straight forward. #### 4. ESF Update

- 4.1. Harjinder Dhami (HD) circulated a Her Majesty's Prison and Probation Service (HMPPS) newsletter (see Annex D) and summarised the ESF papers circulated to members prior to the meeting.
- 4.2. It was agreed that the Prosperous Future Full Appraisal would be circulated to members via written procedure for consideration.
- 4.3. The STEM Full Appraisal was considered by members. HD provided a verbal summary of the appraisal. Mark Reed (MR) summarised comments from TWG. Members agreed to support the project. HD agreed to discuss the potential of slipping the start date of the project back with the applicant.

#### 5. ESF Reserve Fund Request

5.1. Maria Lopez (ML) summarised the ESF Reserve Fund paper circulated prior to the meeting. Members agreed to the proposal to have further ESF reserve fund calls. It was clarified that there will be fortnightly Reserve Fund meetings, 2.1 calls will come forward on another occasion.

#### 6. ERDF Update

6.1. DCo provided a verbal summary of the ERDF Update paper circulated to members in advance of the meeting.

#### 7. ERDF Outline Assessment Consideration

- 7.1. Prior to considering the Outline Assessments DCo clarified that the MA were not accepting overcommitment of LEP areas' PA notional ERDF allocations. However, it is anticipated that a National Reserve fund will established which may provide an opportunity those that are not supported to re-apply for ERDF. Any slippage of contracted projects will be fed into the ERDF National Reserve Fund.
- 7.2.25 Outline assessments were presented to members for consideration. Please refer to Annex C. To summarise;
- **7.3. PA1** StoryLab and ETICC were not supported, all other projects were supported. It was agreed that all supported projects would have a condition requesting that the ERDF requested in the Full Application is less than the Outline Application by a pro rata

amount so that the PA1 ERDF GBSLEP Notional Allocation is not exceeded. It was estimated that this would be roughly 10% across the board. Members noted that there were several materials and advanced material projects in the LEP area and suggested it would be prudent to join up marketing and clarify linkages. Mark Smith (MS) agreed to explore building a link between the organisations.

- 7.4. **PA3** The value of applications received exceeded the remaining allocation for MD in the LEP's PA3 allocation. Applications were subsequently prioritised looking as Strategic Fit, Value for Money, Performance and deliverability. EIGP, Strengthening Automotive Supply Base, The Midlands Internationalisation Fund and STEAMIncubator were not supported, all other projects were supported. It was agreed that PIP2 and BGP 2 capital grant continuation projects would be supported, but that their requests would be subject to an equal pro-rata amount so that the PA3 ERDF GBSLEP Notional Allocation is not exceeded once the value of those not supported had been taken into account.
- 7.5. PA4 EBRI was supported.
- 7.6. **PA6** both projects were supported by the GBSLEP ESIF Sub Committee. It was agreed that the BASIS project would look to reduce the ERDF amount requested by £100k so that the PA6 ERDF GBSLEP Notional Allocation is not exceeded.

#### 8. Midlands Engine Investment Fund (MEIF) Update

8.1. DCo provided a verbal summary of the MEIF paper circulated to members in advance of the meeting. Members supported investing under commitment principally from PA4 in the Midlands Engine Investment Fund.

#### 9. Any Other Business

9.1. It was queried whether the WM5G outline application was missed as was not included in the suite of Outline Assessments considered during the meeting. DCo made members aware that the application was rejected at gateway stage by the MA.
