Introduction

- 1. The consultation sought the views of interested parties on the proposed changes to Her Majesty's Chief Inspector of Education, Children's Services and Skills (Fees and Frequency of Inspections) (Children's Homes etc.) Regulations 2015.
- 2. The consultation sought views on a 10% increase on current fees, for those settings where fees are not already at full cost recovery.
- 3. The online consultation took place between 7th January and 18th February 2019.
- 4. We received eight online responses to the consultation, which included responses from providers of children's homes, representative organisations and voluntary organisations. A list of organisations that responded to the consultation can be found at Annex A.

Summary of responses received

5. The consultation received eight responses. The table below provides a breakdown of the categories of respondents.

Main findings from the consultation

- 6. 75% of respondents were not in favour of increasing fees by 10% where settings were not already at full cost recovery. The main themes emerging from respondents' comments were that:
 - the increased fees will put additional pressure on the budgets of providers;
 - this is not helpful at a time when expansion of the sector is required;
 - the resulting increased costs will be passed on to local authorities by providers;
 and
 - ultimately increased costs risk channelling money away from the provision of services for children and young people.
- 7. One respondent agreed with the fee increases, commenting that the additional cost would be absorbed through budget adjustments.

Question analysis

Question 7

Do you agree with the proposed 10% increases for 2019-20?

This question asked respondents to say whether or not they agreed with the proposed increase to fees, on a scale of strongly agree to strong disagree.

Question 8

How would the proposed 10% annual increase affect you as a provider?

8. This question invited respondents to comment. Eight comments were made. These are summarised in paragraph 6 above.

Government response

- 9. The majority of providers are a long way from paying the full cost of the regulatory activity undertaken by Ofsted. A number of providers are paying less than 25% of full cost recovery with the vast majority paying less than 50% of full cost recovery. This means that taxpayers continue to subsidise providers' regulation, in the majority of children's social care settings.
- 10. While recognising the views expressed in the consultation, given the wide gap between the cost of inspection and many providers' fees, the policy of an annual 10% increase in inspection fees represents a measured way of bringing fees closer to full cost recovery. The government wants to limit the financial burden placed on providers while moving towards the full cost recovery of fees. The level of proposed annual increase has been designed to maintain stability in the market and avoid imposing unsustainable pressure on individual providers.

- 11. Subject to Parliamentary approval, regulations setting a 10% increase in fees in 2019-20 for providers not already paying the full cost of their annual fee and setting a 10% increase in registration/variation fees (as set out at Annex B and Annex C) will come into force in May 2019. As in previous years, the annual fees for settings that have already reached full cost recovery level will be capped at the full-cost rate.
- 12. The annual fees for residential holiday schemes for disabled children remain capped at a reduced rate and the provider and manager registration fee remains the same as 2018-19. This continues to represent a proportionate fee structure in relation to the operating model for this specific setting.
- 13. In the Government response to the consultation on the fees and frequency of inspection regulations 2018-19, we set out that Ofsted would undertake a review of the basis on which fees are set at all levels (annual, registration and variation to conditions of registration).
- 14. Ofsted will still undertake this review but any revisions to the fee structure will not be implemented until April 2020, at the earliest. Any proposed changes to the fee structure will be fully consulted upon before implementation.

Equalities assessment

Question 9

Please provide any representations/evidence on the impact of our proposals for the purposes of the Public Sector Equality Duty (Equality Act 2010).

15. We received four comments. Comments expressed concern that an increase in fees will have an impact on the quality of care for looked-after children, some of whom will have protected characteristics, including those with disabilities.

Government response

- 16. The fee increases will apply equally across all affected children's social care settings. Fees are set according to types of setting and service provided, not according to service users. Those operating children's social care settings remain responsible for ensuring that their services comply with the Public Sector Equality Duty or otherwise with standards established by relevant legislation.
- 17. The existing Ofsted inspection framework has been impact assessed by Ofsted to ensure that children's services are provided in such a way that individuals with protected characteristics are not discriminated against and receive the services they need to the expected standards.
