Dear Martin and Julie,

Re: S31 Grant Determination Letter for Opportunity North East (ONE) Careers and Business Engagement Pilot [No 31/3976 and Project_3918].

This Determination is made between:

- (1) The Secretary of State for Education and
- (2) The North East Combined Authority and the Tees Valley Combined Authority (see Annex A)

I am pleased to confirm further details of the Government's offer to the combined authorities following agreement from the Opportunity North East (ONE) Strategic Board that the proposal put forward jointly by the region's two Local Enterprise Partnerships (LEPs) sufficiently addresses 'Challenge 4' of the ONE programme, by delivering an enhanced careers and business engagement pilot that will deliver a repeating cycle of careers advice and bespoke employment-related opportunities for targeted pupils.

We are devolving this Grant under a Section 31 non-ring fenced transfer (Local Government Finance Act 2003). Our expectation is that the combined authorities will channel the funds to the LEPs who are already incurring costs in support of the aims of the ONE programme. The Senior Responsible Owner for this Grant, Kim Mitchell, will require your responsible officer to confirm at the end of each financial year that the funding has been properly expended. Formal reporting to the Department for Education on progress is not a condition of this grant. The Department for Education will, however, ask

the LEPs to provide voluntary termly reports on activity and expenditure to inform regular updates to the Strategic Board on progress made against the programme's aims

This year, 2019-20, we are making funds available to each LEP in the form of one, non-ring-fenced grant.

This payment takes account of the expenditure already made or committed, and proposed new activity outlined in the proposal put forward by the LEPs, and agreed by the ONE Strategic Board. A total of £22,944.75 will be paid this month, as summarised in Annex A.

Purpose of the Grant

The combined authorities can channel this funding to their LEPs who can spend this grant to promote activity to improve careers advice in the North East, in order to improve outcomes for young people. Whilst you may choose how to spend the money in order to best meet local need, we anticipate that all decisions will be informed by the actions and commitments made in the proposal put forward by the LEPs, and agreed by the ONE Strategic Board.

The Department's aspiration is that the combined authorities should channel the funding to the LEPs to fund their proposal of an Opportunity North East (ONE) Careers and Business Engagement Pilot. Our shared ambition is to reduce the percentage of pupils who become NEET from the schools involved in the pilot. The LEP's proposal aims to achieve this by:

- Creating a shared system for planning and tracking bespoke plans for each pupil benefitting from the programme;
- Engaging with parents and carers about individual pupil needs, and the opportunities available to them;
- Jointly procuring a sustained programme of independent advice and guidance for the identified pupils, so that they benefit from a repeating cycle of advice and bespoke opportunities to help them achieve their goals from now (they are currently in year 9) until they finish 11;
- Working with businesses and providers to identify and create bespoke opportunities to meet the needs of the pupils in the programme;
- Funding in-school activity by the identified careers leads, so that they
 have the capacity to contribute to planning and delivery of the
 programme;
- Covering the cost of transport to enable pupils to access the opportunities offered to them;
- Learning about the impact of this approach, to inform future planning and investment.

The LEPs may also use the grant to pay the salary of staff employed by them to deliver this proposal, and cover reasonable expenses associated with

administering this grant.

We have confirmation that a New Burdens Assessment is not required in this instance because the activity will be undertaken by LEPs.

Payment arrangements

We intend, subject to Treasury approval, to make further section 31 grants in 2020-21, 2021-22 and 2022-23 financial years, to meet the costs incurred by the combined authorities. The exact amounts will be dependent on the use of previous funding and the activity set out in the proposal put forward by the LEPs for the relevant period.

We expect the LEPs to continue to work closely with the DfE towards achieving the aims of the programme, and to maintain existing arrangements for regular discussions with the Opportunity North East team.

This letter has been copied to the two LEPs (Andrew Hodgson, Helen Golightly and Michelle Rainbow of the North East LEP, and Paul Booth and Shona Duncan of the Tees Valley LEP). It has also been copied to Her Majesty's Treasury and the Ministry of Housing, Communities and Local Government.

The Parliamentary Under Secretary of State for the School System ("the Minister of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the Opportunity North East (ONE) Careers and Business Engagement Pilot Determination 2020 [No31/3976].

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

Determination
