

PUBLIC HEALTH SYSTEM REFORM

POPULATION HEALTH IMPROVEMENT STAKEHOLDER ADVISORY GROUP

Scope

- Following the announcement of the new National Institute for Health Protection, which will
 take on PHE's existing health protection functions, DHSC has established a programme of
 work to establish the right future, system and organisational arrangements for improving the
 health of individuals and our population, including relevant PHE functions.
- 2. The Population Health Improvement Stakeholder Advisory Group will provide advice to DHSC on the best future arrangements for prevention and health improvement to ensure we have the best possible capability and capacity to support people to invest in and improve their health.
- 3. It will also consider how best to support a greater focus on prevention and population health in the delivery of local health services and to improve integration so that people receive the joined-up health care and support they need. In doing so, the group will advise on how the proposals will ensure a focus on levelling up between different geographical areas and reducing disparities in health between groups and communities. The group will consider how to strengthen both local and national functions that support improved health and wellbeing outcomes.
- 4. The group will input into a high-level options paper to be published in October for wider engagement, comments and input through a series of roundtables in the autumn to gather views. The aim is to publish the government's final recommended approach and a delivery plan by the end of 2020, post-Spending Review, ahead of consultations with PHE staff.
- 5. The group will not be taking decisions nor will it set or agree policy: it will provide expert advice and opinion to DHSC officials and ministers to support policy development and delivery. It is not a substitute for any formal consultation that may be required on proposals and funding is out of scope for this group.
