### Introductory note

#### **This introductory note does not form a part of the notice.**

The following notice gives notice of the surrender in part of an environmental permit.

Any changes made as a result of the part surrender are set out in the schedules.

The fat traps, along with the associated land, have been surrendered from the permit. These were previously associated with the permitted activity - Section 5.4 Part A(1)(a)(ii) - Disposal of non-hazardous waste with a capacity exceeding 50 tonnes per day involving physico-chemical treatment.

The area of land has been removed from the regulated facility. No other operational changes have been made as a result of this part surrender. The site plan has been revised to remove the fat trap area and also to include the jetty, which is where a directly associated activity and discharge operations are carried out. An additional, up-to-date emission points plan has also been included, although there are no changes to their locations or parameters.

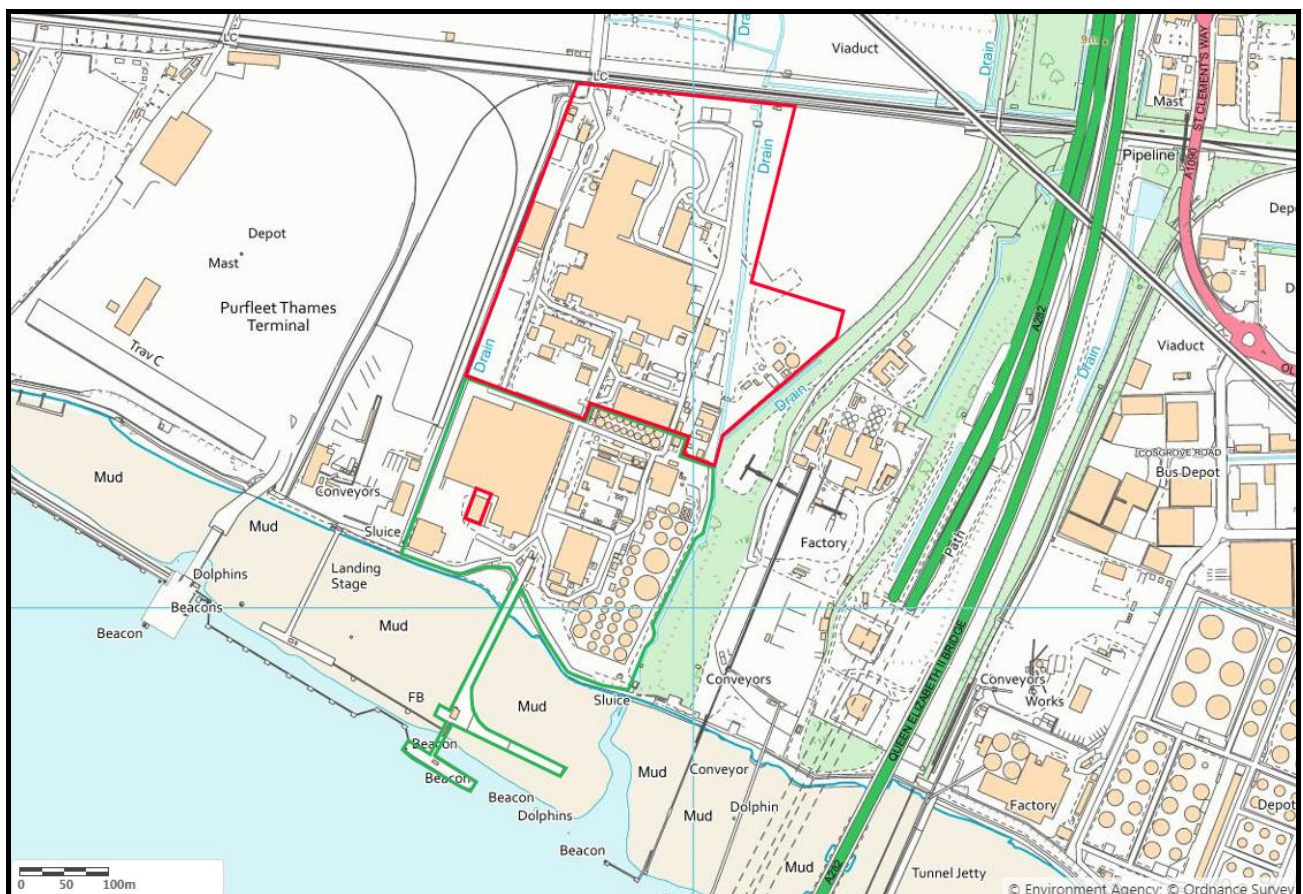
