

The Relationship between the East Midlands Plan and the East Midlands Regional Economic Strategy

The following table maps the vision, targets, priorities and implementation priorities and growth areas of the former Regional Economic Strategy (RES) for the East Midlands onto the policies of the former Regional Spatial Strategy (RSS) for the East Midlands. The former RES and the former RSS now form the Regional Strategy for the East Midlands.

The mapping demonstrates that the RES and RSS are inextricably linked, and that the spatial expression of RES ambitions (i.e. the physical effects of implementing the RES vision, targets and priorities) have been comprehensively considered through the assessment of the environmental effects of the RSS policies against the requirements of the SEA Directive.

The comment column highlights the links to the assessment in **Appendix D** and **Appendix E**.
