## Why do I need to apply for authorisation to remove fish?

The Environment Agency regulates the movement of fish within all inland waters in England. It aims to prevent the spread of fish disease and to minimise damage to fisheries or the environment that may be caused by inappropriate fish movements. It is an offence to take or attempt to take freshwater fish, by any means, without an authorisation/licence from the Environment Agency.

The FR2 form is used to apply for S27A authorisation to use fishing instruments other than rod and line. A fishing (rod) licence is required for removals by rod and line.

#### Permission to fish and Theft Act

Being granted this authorisation does not give you the right or authority to remove fish from private waters; only to use the named instrument(s) in those waters. You should obtain separate permission from the fishery owner and any relevant controlling angling club. Failure to obtain the relevant permissions could leave you liable to legal action.

#### Introducing fish to another site

If you are removing fish in order for them to be introduced to another site, a valid Live Fish Movements Site Permit must be issued for the site prior to the introduction of fish. Further details can be found at: www.gov.uk/guidance/permission-to-move-live-fish-to-orfrom-a-fishery

## **Register your fishery**

Fishery owners whether for personal or commercial purposes, must register their fisheries with the Fish Health Inspectorate (FHI) at Cefas under the Aquatic Animal Health Regulations. The regulations were introduced to maintain the high standards of fish health within the UK.

Registration is a one-off procedure and there is no fee. You will find further information and a registration application form (RW1) at www.gov.uk by searching for 'RW1' or you can call the Fish Health Inspectorate on 01305 206700.

#### What you will receive and when

If your application is successful, you will be sent an authorisation detailing the work you plan to do subject to conditions.

We require 20 working days to process your application, however we will aim to do it within 10. This may take longer if the water this

application relates to has a conservation designation (such as a SSSI), as we may need to consult with other organisations.

The written authorisation only applies to the date, the site, and the fish specified on the authorisation.

# Privacy notice: how we use your personal information

We are the Environment Agency and we issue fish movement permits and authorisations. The information on an authorisation will be retained and processed by us for fish movement activities covered by the authorisation. We are the data controller for this service. A data controller determines how and why personal data (personal information) is processed.

#### The personal data we need

The personal data we collect includes:

- full name
- contact details including postal address, email address, and telephone number(s)

We are allowed to process your personal data because we have official authority to issue fish movement permissions for salmon, trout, freshwater fish, smelt and eel in England and the River Esk catchment area. The lawful basis for processing your personal data is to perform a task in the public interest that is set out in law.

We need the information requested in order to:

- process your application for an authorisation
- allow the use of fishing instruments other than rod and line by issuing an authorisation
- provide an efficient service
- fulfil our statutory duty to maintain, improve and develop salmon, trout, freshwater fish and eel fisheries

If you don't provide the information requested then we can't issue an authorisation to you.

## What we do with your personal data

We use your personal data to issue a suitable authorisation. We do not use your data to make an automated decision or for automated profiling.

We use your personal data to:

- monitor compliance with the authorisation and its conditions
- contact you if we have to make any changes to the authorisation
- consult with the Department for Environment, Food & Rural Affairs, the Centre for Environment, Fisheries & Aquaculture Science, the Fish Health Inspectorate, HM Revenue & Customs, Natural England or Natural Resources Wales when necessary to determine your authorisation
- contact you with important information about related environmental matters
- ask for your feedback on our service

We will not share or disclose your personal data to any other party outside the Environment Agency without your explicit consent, unless lawfully able to do so.

#### How long we keep your personal data

We will keep your personal data for 3 years from when the authorisation is surrendered or expires in line with our standard information retention policy.

#### Where your personal data is processed and stored

We store and process your personal data on our servers in England. We will not transfer your personal data outside the European Economic Area.
