

Why do I need to apply for an authorisation?

The Environment Agency regulates the removal of crayfish from inland waters and the use of fishing instruments other than rod and line. This is to protect fisheries and the wider environment from the impacts of an inappropriate activity, the spread of non-native species and disease transmission.

You must not use your authorised equipment before you have written permission from us. It would be an offence to do so and could result in prosecution.

What you will receive and when

If your application is successful you will be sent an authorisation document along with tags. These must be attached to your equipment at all times when in use. If you lose your tags please contact the Fish Movements Team on 02084 745243 or at fmapplications@environment-agency.gov.uk


We require 20 working days to process your application, however we will aim to do it within 10. This may take longer if the water you plan to trap on has a conservation designation such as a SSSI, as we may need to consult with other organisations.

What if I trap other fish?

All species other than those listed on the authorisation should be returned to the water from where they came, as soon as possible and with as little damage as possible.

Trap dimensions

We may not issue an authorisation if we consider the equipment to be inappropriate. Unless previously agreed in writing, the trap you use must be within the dimensions below.



A: The trap must be no longer than 600mm

B: It must be no wider than 350mm at its widest point

C: The entrance should be no larger than 95mm in diameter.

The mesh size should be no larger than 30mm at its widest point.

Privacy notice: how we use your personal information

We are the Environment Agency and we issue fish movement permits and authorisations. The information on an authorisation will be retained and processed by us for fish movement activities covered by the authorisation. We are the data controller for this service. A data controller determines how and why personal data (personal information) is processed.

The personal data we need

The personal data we collect includes:

- full name

We are allowed to process your personal data because we have official authority to issue fish movement permissions for salmon, trout, freshwater fish, smelt and eel in England and the River Esk catchment area. The lawful basis for processing your personal data is to perform a task in the public interest that is set out in law.

We need the information requested in order to:

- process your application for an authorisation
- the trapping and/or removal of crayfish by issuing an authorisation
- provide an efficient service
- fulfil our statutory duty to maintain, improve and develop salmon, trout, freshwater fish and eel fisheries

If you don't provide the information requested then we can't issue an authorisation to you.

What we do with your personal data

We use your personal data to issue a suitable authorisation. We do not use your data to make an automated decision or for automated profiling.

We use your personal data to:

- monitor compliance with the authorisation and its conditions
- contact you if we have to make any changes to the authorisation
- consult with the Department for Environment, Food & Rural Affairs, the Centre for Environment, Fisheries & Aquaculture Science, the Fish Health Inspectorate, HM Revenue & Customs, Natural England or Natural Resources Wales when necessary to determine your authorisation
- contact you with important information about related environmental matters
- ask for your feedback on our service

We will not share or disclose your personal data to any other party outside the Environment Agency without your explicit consent, unless lawfully able to do so.

How long we keep your personal data

We will keep your personal data for 3 years from when the authorisation is surrendered or expires in line with our standard information retention policy.

Where your personal data is processed and stored

We store and process your personal data on our servers in England. We will not transfer your personal data outside the European Economic Area.
