SUMMARY OF THE DEVICES EXPERT ADVISORY COMMITTEE MEETING HELD ON $14^{\text{TH}}\,\text{MAY}\,2020$

The Devices Expert Advisory Committee (DEAC) discussed the following agenda items:

Matters arising from the minutes

The planned communication on nebuliser use at home by children with asthma has been delayed in order to update it to be relevant to the current Covid-19 emergency situation. The comments were noted and that the MHRA will consider including further communications in the current context for UK healthcare.

Devices division policy and strategy

The Committee received two papers and a supporting presentation about the Division's response to Covid-19. They were supportive and congratulated the Agency for its rapid and thorough work in response to this emergency.

Expert advice on regulatory actions

The Committee received a paper that included a position statement by the PRASEAG as well as a summarising presentation on BIA-ALCL. The DEAC strongly supported the suggestions for improving the provision of information to patients and the public about the risks of ALCL with breast implants; the strengthening of the consent process; and the improvement in National Registry usage and data sharing for breast implants. The Committee recommended that urgent priority be given to progressing these actions. The Committee suggested that the implications of the differential indication for breast implants, either reconstructive or cosmetic, on patient and clinician risk assessment as well as on the consent process be further elucidated. The Committee recommended that the proposed manufacturer documentation review should be completed as a matter of urgency, notwithstanding the current pressures on the Devices Division team as a result of the Covid-19 pandemic, and that this information be reported back to DEAC as soon as it is available for further consideration.

The Committee receive a paper and a supporting presentation on a spinal implant system. They supported the regulatory actions recently taken by the MHRA Devices Division including the establishment of a spinal EAG to provide further expert advice. The DEAC suggested that membership of the EAG could be extended to include a paediatrician, patient and lay person.
