Project: Highfields School, Derbyshire, to join East Midlands Education Trust

HTB discussion:

Ofsted Good May 2017 (short inspection).

Voluntary conversion.

Percentage of pupils meeting expected standard in reading, writing and maths is below national average.

School wishes to join trust as it closely meets criteria set out in selection process.

Trust offers strong school to school support, which will help drive further improvement at school.

Trust has capacity for school to join.

The financial health of the school, strength of financial management and governance at the trust and impact on the trust's future financial health if this school joins were considered.

Supportive deployment of a School Resource Management Adviser (SRMA) is already pending.

Percentage of pupils meeting expected standard in reading, writing and maths is below local and national average for last three years.

Trust has proven track record and history of school improvement.

Board raised concerns regarding low pupil numbers. However pupil numbers are forecasted to increase over time.

### Significant change

Project: Goole Academy, East Riding of Yorkshire- closure of sixth form provision

HTB discussion:

Ofsted Requires Improvement November 2015.

Low sixth form pupil numbers making the provision financially unviable.

Four of the other schools in trust have closed their sixth form provision, which have been consolidated at Don Valley in Doncaster.

Local authority have expressed no objections to proposal.

Closure will not have detrimental impact on viability of school.

The financial health of the school, strength of financial management and governance at the trust and the impact of the significant change on the trust's future financial health was considered.

# Project: Ashby School, Leicestershire- removal of boarding provision and in year variation to admissions

HTB discussion:

Ofsted Inadequate October 2019.

School provides boarding provision for up to 75 boys in the age range 14 - 18 years old.

School considers boarding provision to be no longer financially viable.

Alternative options have been considered but failed to meet the test of financial sustainability and quality of provision.

The impact of Covid-19 and of exiting European Union has accelerated the need for urgent action. Local authority has no objections to proposal.

School has advised staff and provided support to pupils to find alternative arrangements.

Proposal to take effect from August 2021.

The financial health of the school, strength of financial management and governance at the trust and the impact of the significant change on the trust's future financial health was considered.

# Project: Thomas Estley Community College, Leicestershire- creation of a 15 place Special Educational Needs and Disabilities Communication and Interaction Unit

HTB discussion:

Ofsted Good January 2019

Proposal to take effect from August 2021 and is fully supported by local authority, due to it being part of their Special Education Needs and Disability Strategy.

All students attending will have an Education, Health and Care Plan.

Places to be allocated by local authority.

Planning permission has been obtained. Capital funding for construction will be met by the local authority. Local authority to also provide trust with start-up grant to establish the unit.

Unit will be opened on a phased basis in August 2021 and is expected to be at full capacity by August 2022.

Full consultation undertaken, with no objections.

The financial health of the school, strength of financial management and governance at the trust and the impact of the significant change on the trust's future financial health were considered.

Supportive deployment of a School Resource Management Adviser (SRMA) recommended.

# Project: Boston Grammar School, Lincolnshire - increase physical capacity from 643 to 740 following physical expansion

HTB discussion:

Ofsted Requires Improvement March 2018

Expansion required due to increase in demand for secondary school places.

Trust advised that the school has grown significantly over the last six years.

Headteacher advised school is full and class sizes are large.

No objections from neighbours or parents about the proposal.

The financial health of the school, strength of financial management and governance at the trust and the impact of the significant change on the trust's future financial health were considered.

Deployment of a School Resource Management Adviser (SRMA) is pending

# Project: Greenfields Academy, Lincolnshire – increase in capacity at the Special School from 65 to 78

HTB discussion:

Ofsted Good January 2020

Proposal does not require physical expansion to be implemented. Therefore no capital costs required. Additional funding required to accommodate additional staffing costs, which will be provided by the trust.

Fully supported by local authority as it contributes to the delivery of their Special Education Needs and Disability Strategy and addresses the increase in demand for places.

Full consultation undertaken, with one negative response, which was considered.

The financial health of the school, strength of financial management and governance at the trust and the impact of the significant change on the trust's future financial health was considered.

School Resource Management Adviser (SRMA) currently deployed.

### **Sponsored route**

#### Project: Surfleet Primary School, Lincolnshire - consider sponsor options

HTB discussion:

Ofsted Inadequate February 2019.

School issued with Directive Academy Order in July 2020.

Number of trusts expressed interest but Keystone Academy Trust considered most suitable match.

Trust has track record of driving school improvement and schools in the area to provide support.

Trust has identified school's areas for improvement and has plan in place to address them.

Board raised concerns regarding the growth strategy of the trust.

The financial health of the school, strength of financial management and governance at the trust and the impact on the trust's future financial health of this school joining it was considered.

School Resource Management Adviser (SRMA) currently deployed.

RSC decision: Approved

### **Trust change**

Project: Sentamu Academy Learning Trust merging with Hope Learning Trust

HTB discussion:

Proposed merger will create a faith-based trust, which will span two Regional School Commissioner regions (North and East Midlands and Humber), and will comprise fifteen schools.

Risks associated with merger discussed, along with revised governance arrangements.

Hope Learning Trust has proven track record of delivering school improvement. The trust's school improvement model will be bespoke for each individual school.

Robust financial planning and forecasting of budgets undertaken.

Board raised concerns regarding the ambitious delivery timescales, especially due to current pandemic.

Board advised that merger should be implemented for September 2021 rather than April 2021, in order to allow further time for planning and preparation.

The current financial health of the individual trusts, forecast financial health of the merged trust and strength of the proposed financial management and governance arrangements were considered.

Supportive deployment of a School Resource Management Adviser (SRMA) recommended.

RSC decision: Approved for September 2021.
