



Enforcement Action taken in the period: 1 October 2018 to 31 March 2019

The Office for Product Safety and Standards is part of the Department for Business, Energy & Industrial Strategy. We oversee the regulatory system for product safety and standards in the UK. Our purpose is to make regulation work, so that it protects people and enables businesses to understand their obligations. The statutory enforcement actions listed below were taken by the Office in 2018 – 2019.
