In total there were 348 attendees, 236 from LAs, 112 from DWP Partnership Teams.

The events gave visibility to all LAs of the type of issues that are discussed with POG and LAWSG and the events were shaped utilising information obtained as part of our issues resolution process and feedback from LAs/DWP Partnership Managers.

The events were used to communicate to LAs and DWP Partnership Managers what's happening in relation to Housing Benefit across DWP and HDD and the Universal Credit (UC) Programme.

An electronic evaluation questionnaire was issued following each event to the attendees.
