Grenfell Tower site update: summary and Q&A from 2 February online event

At our online community information event on 2 February 2021, we updated attendees on the rewrapping of the Tower, the safety works taking place at the site, the procurement of the site's principal contractor and how we plan to increase 'social value' opportunities for local residents and others.

We also shared details of how you can give your thoughts about the Tower and the future memorial as outlined in the letter we sent to the community and gave a reminder about the health and wellbeing services available. Event attendees were able to post questions to our panel from the Grenfell site management and programme team, and to a member of the local NHS health team.

Planned safety works

We are fitting additional 'props' (aluminium supports) in the Tower so that we can ensure the building's continued stability. To enable the installation of these props, we have been removing heavy, damaged items and asbestos from individual flats.

The principal contractor for the Grenfell Tower site

The principal contractor is responsible for carrying out the safety and day-to-day maintenance works on the Grenfell Tower site. Our existing contract with the on-site contractor will expire in June 2021 and we need to re-procure the contract due to government rules and guidance on spending public money. This is a standard process and is part of our role in keeping the site safe. Potential suppliers will give a presentation to interested members of the community in March – please contact us using the details at the end of this update if you would like to attend.

Social value

An important part of the procurement is social value. This means that the companies contracted by the Ministry of Housing, Communities and Local Government (MHCLG) agree to bring benefits to the community as part of their agreed work. Recent examples include providing work experience opportunities, and free online courses in construction and business administration. We are working with the community to understand what is important for them in terms of social value, and we have set up a group to hear and involve the community in the process so far.

Rewrapping the Tower

The outer layer of white wrapping around Grenfell Tower deteriorates over time and needs to be replaced regularly, which we have been doing once a year. We are scheduled to begin the next replacement on 6 March and it will take around 10 weeks, depending on the weather. The Tower will not be visible while the rewrapping takes place. The rewrapping will be carried out sensitively and is not expected to cause disruption. For further details, see the Q&As below, or our information leaflet

Questions and answers

Thank you very much to all of you who submitted questions to the panel. This is a summary of the questions and answers.

Q Have you contacted families about the future of the Tower?

A: Yes. We wrote to families in January (you can see the letter here). As the owner of the Grenfell Tower site, the government wants to hear the thoughts of bereaved family members, former residents of the Tower, local residents and the North Kensington community on decisions and activity relating to the Tower. A decision has not yet been made about what will happen to the Tower and we don't underestimate how difficult this will be, particularly for bereaved families.

We want to hear from as many of people as possible, particularly bereaved families and survivors, before any decision is made. See the letter, or the details in the Q&A below, for how you can share your thoughts.

Q: How many people have Kaizen spoken to on the Lancaster West estate?

A: Kaizen, (the independent community engagement team appointed by the government to hear the community's thoughts on the Tower and the future memorial), has so far spoken to around 218 residents on the estate. Kaizen would like to hear from as many people as possible. Any residents who would like to share their thoughts can do so in a way that suits them best.

Q: Why are you rewrapping the Tower again?

A: The Tower is wrapped for a number of reasons: to protect the building from the weather, to sensitively and respectfully cover the building from view, and for the safety of any workers on the scaffolding between the wrapping.

There are two layers of wrapping around the Tower – a blue inner layer and a white outer layer; the outer layer deteriorates over time and must be replaced once a year. The rewrapping takes place in stages and the Tower will not be visible while the rewrapping takes place as the blue inner layer won't be changed. We expect the next phase of rewrapping to start on 6 March and last for around 10 weeks. However, the work is weather dependent, which may change the timetable slightly. We will ensure that the rewrapping is carried out as sensitively as possible, and is not expected to cause disruption to the community.

Q: Will schoolchildren at Kensington Aldridge Academy (KAA) next door to the Tower be able to see the Tower when the wrapping is being replaced?

A: No. What will be visible is the area where the outer layer of white wrapping has been removed, the blue layer beneath that and some of the scaffolding.

We are working with KAA and other local schools to make sure that we carry out the rewrapping at times when it will cause the least amount of disruption to the school.

Q: Can you explain the safety works - are they the start of the Tower being taken down?

A: The safety works are not about bringing down the Tower. They involve careful removal of loose materials and heavy items from the Tower and the installation of further props to ensure its continued stability until a decision is taken about its future. These works are needed whatever the future of the Tower.

As owner of the Tower site, the government is responsible for making operational decisions but has not made any decision on the future of the Tower. The government has publicly committed that any decision on the future of the Tower will only be made after speaking and listening to the community.

Q: I thought the Memorial Commission decides what happens to the Tower.

A: The independent Grenfell Tower Memorial Commission is not responsible for deciding what happens to the Tower. The Memorial Commission will develop, with the community, a vision for the memorial to those who lost their lives in the tragedy.

As the owner of the Grenfell Tower site, the government has publicly committed that any decision will only be made after hearing from the community.

The government wants to hear from bereaved family members, survivors, local residents and the North Kensington community, on decisions and activity relating to the Tower.

A decision has not yet been made about what will happen to the Tower. We don't underestimate how difficult this decision will be, particularly for bereaved families. We want to hear your views before a decision is made, and to ensure you are supported to have your say.
