**URGENT FIELD SAFETY NOTICE- RECALL**

Dear Valued Customer:

Smiths Medical is providing this Urgent Field Safety Notice to advise its customers of a recall for certain Portex® Endotracheal Tube Holders (“ET Tube Holders”) sold as stand-alone products and packaged in intubation kits. Smiths Medical is voluntarily taking this recall with the knowledge of the relevant Regulatory Agencies.

Smiths Medical has become aware of a small number of users encountering difficulty when passing the suction catheter through the endotracheal tube when the holder is locked or have experienced difficulty when locking the holder. These conditions could present a delay in therapy while replacement product is obtained or could result in an accidental tube extubation if the ET Tube Holder fastener is loosened in an effort to suction the patient. Smiths Medical has received no reports of permanent injury related to this issue.

**Only those Product Reorder Codes and Lot Numbers listed in Attachment 1 are impacted by this Field Safety Corrective Action.**

**Advice on Action to be Taken by the User:**

Subject to this Field Safety Corrective Action, Smiths Medical is requiring its customers to:

1. Inspect your inventory and segregate any unused affected products (refer to Attachment 1); and
2. Complete and return the Confirmation Form (Attachment 2), either by fax at +44 (0) 1233 722153 or by e-mail to: [EndoTrachealTubeHolders@smiths-medical.com](mailto:EndoTrachealTubeHolders@smiths-medical.com) within 7 days of receipt of this notice.

Upon receipt of the completed form, a customer service representative will contact you to arrange for exchange of your unused affected inventory for credit or replacement. Replacement products may not be immediately available; therefore, a list of alternative replacements is listed in Attachment 3.

**Transmission of this Urgent Field Safety Notice**

This notice shall be passed on to all personnel who need to be aware within your organization, including points of use or to any organization where the potentially affected devices have been transferred. If you or your facility has distributed these affected products to other persons or facilities, please promptly forward the recipients a copy of this Urgent Field Safety Notice.

Please maintain awareness of this Notice and resulting action for an appropriate period to ensure effectiveness of this Recall.
