URGENT FIELD SAFETY NOTICE

Update: Vitrea Z-Axis Measurement Error for Vitrea software versions 6.3.2 and prior

FSCA-identifier: EU13VI_A

Type of action: Device Modification; Caution Regarding Measurement Error

This is a follow-up communication to the original voluntary recall initiated by Vital Images, Inc. on February 5, 2013. This is a voluntary action, supporting our dedication to provide quality products to our physicians and patients.

Products affected by this amended notification are Vitrea Enterprise Suite, VitreaAdvanced, VitreaCore (VitalConnect) and Vitea fX including all versions 6.3.2 and prior.

Note: Versions 6.3.0, 6.2.3 and 6.1.6 are now impacted by this amended notification.

Vital Images has made a decision to perform a voluntary field correction to the above software versions. Vital Images has identified an error regarding measurements for images that are viewed using Vitrea.

This error occurs when images are rotated only around the Z-axis. Images rotated around the X-axis or Y-axis will not be affected, whether or not they are also rotated around the Z-axis.

Further, this error exists in rotations in non-90 degree increments of the transverse/axial plane (rotation around the z-axis), while not being simultaneously rotated around the x-axis and y-axis. Vital found this orientation adjustment to occur on rare occasions, such as to straighten tilted head or neck scans, usually with minimal effect on measurements. However, under certain conditions, this error may result in large length, area, and volume measurement differences.

Please use caution when reviewing measurements of images reconstructed with orientations that are adjusted in such a manner. This issue was found through internal testing. No customer reports of the issue have been received.

Next Steps

- 1. Immediately inform all potential users of Vitrea of the information contained in this field safety notice letter.
- 2. It is recommended that all measurements associated with this error be verified against results from other technologies.
- 3. Follow your institutions policy and procedures on FDA Class II recalls.

Your facility must complete and return this form even if you are not currently impacted by this action. This information is essential in order to maintain recall effectiveness information required by FDA.

Vital Images is preparing upgrades for this error for versions 4.1, 6.0 and 6.2. Upgrades are currently available for version 6.3. Those customers using versions 6.4 or higher are unaffected by this error.

Direct customers of Vital Images and customers of Toshiba America Medical Systems (TAMS) will be contacted by Vital Images Customer Support to arrange for an upgrade. Customers who received the products through a distributor will be contacted by their distributor to arrange for installation of the upgrade. We recommend that you implement the upgrade.
