### **Proposed Merger between RSCH and Ashford and St. Peter's Hospitals**

Several members of the Witley and Milford PPG have attended meetings where this proposed merger was discussed. We have seen the information on the relevant websites, and discussed the matter at our own recent meeting. We hope that the following observations may be of interest. You will see that they relate mainly to the benefits that the proposed merger is intended to bring to patients.

### **General**

Generally speaking, it is not immediately obvious that the claimed benefits, even assuming them to be desirable, would follow automatically from the merging of the two Trusts. In some cases greater co-operation between existing institutions might seem a more promising way forward. We notice that a Full Business Case has yet to be made, and we suspect that the devil may lie in the detail.

### **Wider range of specialist services locally instead of in London**

It is hard to oppose this if it can be achieved without detriment to other services. We do believe, however, that a patient with a condition requiring an exceptional kind of expertise will be prepared to travel far to get it. Localism is not a great virtue in a case like this.

### **Increased 7-day working with consultant reviews every day for in-patients**

It is not obvious how this would follow, unless the merger saved money which could then be spent on improved provision. The published proposals do not claim any financial benefits.

### **Improved access to cutting-edge treatments via local universities**

Again, one hopes this might be done by existing hospitals. Even sharing the cost and usage of expensive equipment might surely be achieved by co-operation.

### **Maximising benefits of digital technology**

No doubt desirable, but a merger is not the obvious way to achieve it. Indeed a merger might bring its own organisational problems, delaying attention to other matters.

### **Travel implications**

Although reassurance has been given on this point, we do wish to emphasise that for the members of our group the implications for travel and access are a major consideration, at least for the more routine types of hospital treatment. This is especially important when the patient is a child and frequent visits by parents and other family are almost as important as the medical treatment. Our experience shows that the parking at St. Peter's Hospital is particularly bad, while the situation at Royal Surrey is a constant source of complaint. The merger might well have implications for local community bus services like the Hoppa. Whether a merger would require more travelling by doctors and consultants is not perhaps our immediate concern, but we do not wish to see expensive people spending too much time on the road.

### **Reduction of choice**

Subject to these other considerations, we would wish to support the CMA in regretting any reduction in the choice available to patients.

### **Clinicians**

Our members attach some weight to the fact that, on the evidence of meetings attended, many clinicians remain to be convinced of the benefits of the merger.
