### 1. Introduction

The 2014 to 2020 European Structural and Investment Funds bring the European Regional Development Fund, European Social Fund and part of the European Agricultural Fund for Rural Development together into a single European Union Structural and Investment Funds Growth Programme for England supporting the key growth priorities of innovation, research and development, support for Small and Medium Sized Enterprises, low carbon, skills, employment, and social inclusion.

The Funds are managed by the Department for Communities and Local Government for European Regional Development Fund, Department for Work and Pensions for European Social Fund and the Department for Environment, Food and Rural Affairs for European Agricultural Fund for Rural Development. These Departments are the Managing Authorities for each Fund. In London, the Greater London Authority acts as an Intermediate Body for the European Regional Development Fund and European Social Fund programmes. In some areas, Intermediate Bodies are being designated to undertake delegated tasks and functions (the assessment against selection criteria in relation to fit with local priorities). Unless stated otherwise, the term "Managing Authority" will apply to all these organisations. The Managing Authorities work closely with local partners who provide:

- 1. Practical advice and information to the Managing Authorities to assist in the preparation of local plans that contribute towards Operational Programme priorities and targets;
- Local intelligence to the Managing Authorities in the development of project calls (decided by the Managing Authorities) that reflect Operational Programme and local development needs as well as match funding opportunities; and
- 3. Advice on local economic growth conditions and opportunities within the context of the Operational Programme and the local European Structural and Investment Fund Strategy to aid the Managing Authorities' assessments at outline and full application stage.

This call is issued by the Department for Communities and Local Government and invites Outline Applications in respect of the European Regional Development Fund for England 2014 to 2020.

# 2. Call Context

On behalf of the national Growth Programme Board, the Department for Communities and Local Government (the Managing Authority) invites applications seeking European Regional Development Fund support under:

#### Priority Axis 1 Promoting Research and Innovation

#### **Investment Priorities:**

- **1a** enhancing research and innovation infrastructure and capacities to develop research and innovation excellence, and promoting centres of competence, in particular those of European interest.
- **1b** promoting business investment in research and innovation; - developing links and synergies between enterprises, research and development centres and the Higher Education sector, in particular promoting investment in product and service development, technology transfer, social innovation, ecoinnovation, public service applications, demand stimulation, networking, clusters and open innovation through smart specialisation;

-and supporting technological and applied research, pilot lines, early product validation actions, advance manufacturing capabilities and first production, in particular in key enabling technologies and diffusion of general purpose technologies.

The European Regional Development Fund Operational Programme for England 2014 to 2020 sets out how the European Regional Development Fund will focus on investment to support economic growth and job creation. Priority Axis 1 of the Operational Programme aims to improve how Small and Medium Sized Enterprises commercialise research and how they collaborate with research institutions.

Any application for funding will be required to clearly demonstrate that it meets the requirement of, and makes a meaningful contribution to, the delivery of the relevant Priority Axis of the <u>European Regional Development Fund Operational Programme</u>.

In addition, applications will be expected to meet identified local development need, as expressed in the scope of this call and as set out in the <u>Heart of the South West</u> <u>Local Enterprise Partnership Area</u> European Structural and Investment Funds Strategy.

Applicants are advised to familiarise themselves with the detail of the Operational Programme, local European Structural and Investment Funds Strategy and the relevant documentation listed in sections 5 through to 8 *prior to* submitting an Outline Application.

# 3. Scope of the Call

### 1. Scope

This call invites Outline Applications which support the delivery of **Priority Axis 1** of the European Regional Development Fund Operational Programme and responds to the local development need set out in the <u>Heart of the South West Local Enterprise</u> <u>Partnership area</u> European Structural and Investment Funds Strategy.

Indicative Fund Allocation:	<ul> <li>Indicatively, through this call the Managing Authority expects to allocate up to £8,025,000.</li> <li>The Managing Authority reserves the right to increase or decrease the indicative allocation, or support more or fewer projects subject to the volume and quality of proposals received.</li> <li>There is no indicative allocation of European Regional Development Fund funding between capital and revenue activity, both capital and revenue is eligible dependent on the nature of activities/Investment Priorities set out in the call.</li> </ul>
Minimum application level	European Regional Development Fund investment is intended to make a significant impact on local growth. Applications are expected to demonstrate appropriate scale and impact. The Managing Authority does not intend to allocate less than £500,000 European Regional Development Fund to any single project. Consequently projects with a total value of less than £833,333 will not be supported under this call.
Duration of project approvals	Projects should be for a maximum of three years, however the Managing Authority reserves the right to vary the maximum duration in exceptional circumstances.
Geographical Scope	All interventions are confined to activity and beneficiaries within England. The Heart of the South West Local Enterprise Partnership Area is, for the purposes of European Structural and Investment Funds, divided into two Categories of Region. The Transition Region covers Devon County and Torbay and Plymouth Unitary Authorities while the More Developed

	Region covers Somerset. In the Transition Region it is possible for the grant contribution rate to be up to 60% whereas in the More Developed Region, the maximum grant contribution rate is 50% (see section 6.3.) This call relates to the Transition Region. Capital Projects should be located within and revenue projects should predominantly support businesses based in the Transition Region of the Heart of the South West Local Enterprise Partnership area.
Specific call requirements	Applications are sought for interventions which address the challenges faced by the <b>big data</b> , <b>environmental futures</b> , <b>healthy ageing</b> , <b>marine and agri-technology smart</b> <b>specialisation sector</b> , to help to stimulate growth and productivity. It is anticipated that multiple contracts will be awarded. Applicants should note that primary production, processing and marketing of agricultural products is ineligible for
	<ul><li>European Regional Development Fund support.</li><li>Applicants are advised to review the investment priorities and associated output indicators.</li><li>Applicants should note that the outputs contained in the European Regional Development Fund Operational</li></ul>
	Programme are the absolute minimum to be achieved. Local partners and the Managing Authority expect applicants to present an ambitious set of outputs, demonstrating good value for money. Applicants will need to have eligible match funding for the
Coll Doodlings	balance of the costs which must be from a source other than the European Union. Applicants are responsible for identifying the match funding required to complete the funding package.
Call Deadlines	For this specific call, applications will be assessed after the close of the single deadline. Applications received after the published call close date will not be considered.

### 2. Local Development Need

Projects must deliver activity which directly contributes to the objectives of Priority Axis 1 of the Operational Programme, one or more of the relevant Investment Priorities and meet the **local development need** expressed in the table below.

#### LOCAL DEVELOPMENT NEED

#### Local Economic Context :

Despite high quality university provision, the Heart of the South West is one of the worst performing Local Enterprise Partnership areas against measures of innovation. This is set out in more detail in the '<u>Heart of the South West Local Enterprise</u> <u>Partnership Area European Structural and Investment Fund Strategy</u>'. In particular, applicants are invited to consider the 'business' section of 'understanding our growth potential'.

This call relates to 'Integrated Activity A' of the Heart of the South West Local Enterprise Partnership Area European Structural and Investment Fund Strategy. This activity seeks to address underperformance by maximising innovation through transformational opportunities and smart specialisation.

Smart specialisation is about a more evidence-based, dynamic and realistic strategy of supporting innovation. Its primary focus is on encouraging specific sectors and clusters of innovation within areas that have unique advantages.

In the Heart of the South West, partners have developed the <u>Heart of the South</u> <u>West smart specialisation approach</u> which sets out the rationale and evidence base for the selection of smart specialisation priority areas.

The smart specialisation priority areas included within this call are:

- Big data;
- Environmental futures;
- Healthy ageing;
- Marine; and
- Agri-technology.

Pages 32 – 65 of the 'Heart of the South West smart specialisation approach' give further details about each sector in the Heart of the South West. It describes the local context, existing assets and infrastructure, and sets out barriers to growth and potential interventions.

Proposals are invited which deliver one or more of the indicative actions set out under investment priorities 1a and 1b of the Operational Programme, listed below in section 3.3.

Proposals should also demonstrate alignment with those activities described within 'Integrated Activity A' of the 'Heart of the South West Local Enterprise Partnership Area European structural and investment fund strategy' and the 'Heart of the South West approach to smart specialisation'.

The Managing Authority intends to award multiple contracts according to the following indicative allocations:

- Big data £900,000
- Environmental futures £2,700,000
- Healthy ageing £900,000
- Marine £2,700,000
- Agri-technology £825,000

Applications which cover more than one smart specialisation priority sector are welcomed.

Applicants should be aware that another call is being issued alongside this call, inviting applications which support the smart specialisation area of photonics.

It is anticipated that further calls will be issued in the Heart of the South West Local Enterprise Partnership area for activity to support the other sectors identified through the local smart specialisation approach in the more developed area.

#### Local Priorities:

Proposals should demonstrate alignment with local development need and priorities including:

- Identifying which smart specialisation sector(s) the proposal supports. Where activity covers more than one smart specialisation sector, the applicant is invited to describe additional value the suggested approach provides.
- A detailed description as to how the project aligns with the '<u>Heart of the South</u> <u>West smart specialisation approach</u>', drawing on the relevant sections of the document, and describing how the proposal will capitalise on current strengths/opportunities and address weaknesses/barriers.
- A description of how the activity complements the <u>'Smart Specialisation in</u> <u>England strategy'</u>, also identifying and demonstrating alignment with relevant institutions or initiatives elsewhere in the UK and articulating how the proposal takes advantage of these.
- Identifying existing infrastructure for innovation support for each relevant sector in the Heart of the South West. To ensure that the proposal supports the ongoing development of an effective 'innovation ecosystem' as a sustainable legacy, the applicant is invited to describe how the proposal will capitalise on and augment these existing assets. This should include specific reference to Innovate UK activity.
- Demonstration that there is unmet demand for the proposal, how proposals will drive productivity in the sector(s), and have long term impacts.
- A description of how the proposal will align with the recently commissioned <u>Heart</u> of the South West Growth Hub 'Service for All' This would include:
  - Applicants working with the Heart of the South West Growth Hub to offer a joined up service for businesses.

- Regularly sharing information with the Growth Hub and the Heart of the South West Local Enterprise Partnership to inform strategic planning.
- A description of how the applicant will work with the Local Enterprise Partnership's Business Leadership Group, and use this group to provide strategic oversight of the activities proposed.
- An explanation of how the applicant will work closely with any European Social Fund skills provision and any national skills provision to support an increase in higher level skills to underpin economic growth.

### 3. Operational Programme Investment Priorities

Applications must specify the activities to be delivered and are expected to directly contribute to **one or more** of the following Investment Priorities:

The focus of activity under this priority axis is improving commercialisation of new or enhanced products or services by Small and Medium Sized Enterprises, whether through increased investment or better collaborations, but this requires the involvement of a much wider group including larger firms in cooperation with their supply chains and other Small and Medium Sized Enterprises, Higher Education institutions, public sector institutions and research centres, Catapult Centres and other centres of excellence.
Projects under this investment priority, including pilot or demonstrator activity, may include capital spend where this is integral to their delivery. This may include enhancements to premises or new build, equipment and facilities. Where new premises are to be built, then there must be clear evidence that demand is not met by existing supply.

# 4. Required Outputs under this Call

Projects must deliver against the Priority Axis 1 outputs of the European Regional Development Fund 2014 to 2020 Operational Programme. For projects coming forward under this call the expected outputs and results are:

Applicants will need to demonstrate how the eligible activity, funded by the European Regional Development Fund, will achieve the outputs committed to within the proposal. The application should clearly state the methodology used to determine the levels of outputs proposed.

All operations will be required to report regularly on progress toward achievement of targets. This will need to include both quantitative and qualitative data relevant to the appropriate geographical areas. Applicants will need to explain how they will collect and record this information to maintain a fully evidenced audit trail. It should be noted that if an operation fails to deliver contracted outputs, a performance penalty may apply.

# 5. Application Process & Prioritisation Methodology

There are two stages to the European Regional Development Fund application process;

- 1. Outline Application and, if successful
- 2. Full Application.

Acceptance of an Outline Application to progress to full application stage does not in any way indicate or constitute an offer of European Regional Development Fund grant.

Applicants must fully complete the <u>Outline Application</u> which will be assessed by the Managing Authority against the national <u>Selection Criteria</u>. Where an Intermediate Body has been designated to undertake delegated tasks and functions, the Intermediate Body will undertake the assessment of some selection criteria in relation to fit with local priorities.

Outline Applications will be assessed in two stages, Gateway assessment and Core assessment.

Gateway assessment considers:

- applicant eligibility;
- activity and expenditure eligibility; and
- fit with the National Operational Programme and the local development need set out in section 2.

Proposals that fail the Gateway assessment undertaken by the Managing Authority will be rejected. Proposals which pass the Gateway assessment will then be assessed against the Core assessment criteria:

- Strategic Fit
- Value for money
- Management and control
- Deliverability
- Compliance
  - o Procurement
  - $\circ$  State Aid
  - Publicity requirements
- Cross cutting themes
  - o Environmental sustainability
  - Equal Opportunities

Having assessed projects against these criteria the relevant Local Economic Partnership area European Structural and Investment Fund Sub-Committee will advise the Managing Authority or Intermediate Body as relevant on the contribution to local economic growth conditions and opportunities within the context of the Operational Programme and local European Structural and Investment Fund Strategy to aid the Managing Authority's assessments (at outline and full application stage). Please note that the Managing Authority's decision is final and there are no appeals. ### 6. General Information

### 1. National Eligibility Rules

When developing an application, Applicants must refer to the <u>National Eligibility</u> <u>Rules</u> setting out the requirements of the 2014-2020 European Regional Development Fund Programme. It is the responsibility of the Applicant to ensure that the Rules are adhered to both at application stage and following approval. Failure to do so can lead to financial penalties leading to recovery of up to 100% of grant. Applicants are strongly advised to seek specialist advice if in doubt on any requirement.

European Regional Development Fund eligibility rules apply to **all** project spend within the eligible costs, including match funding.

The European Regional Development Fund is governed by European regulations and national rules. Applicants are advised to familiarise themselves with the relevant documentation, (Section 8 Key Document refers) prior to submitting an Outline Application. If successful, Applicants will enter into a Funding Agreement and must abide by the standard terms and conditions contained therein. Applicants are therefore strongly advised to read these terms and conditions to ensure that they are able to enter into such an agreement prior to responding to the call. Once a Funding Agreement has been issued it should be signed and returned within 30 days, unless otherwise agreed with the Managing Authority.

#### 2. Eligible Applicants

Section 4 of the National Eligibility Rules sets out who is eligible to apply.

Applicants must be legally constituted at the point of signing a Funding Agreement. If the application is approved the Applicant organisation will enter into a legally binding Funding Agreement and therefore will carry the liability for ensuring that the terms and conditions of the Funding Agreement are met.

If there is more than one organisation applying for the funds, a lead organisation must be selected to become the Applicant with the remaining organisation(s) acting

as Delivery Partner(s). In this situation the Applicant would be responsible and liable for the Delivery Partner(s) and ensuring the project is operating compliantly.

During the application process the Managing Authority will consider the Applicant's track record, both positive and negative. If the Applicant has been involved in the delivery of previous European grants and any irregularities have been identified, the Managing Authority will expect to see how and what steps have been taken to ensure that the risk of further irregularities in the future is mitigated. It is acknowledged that some organisations will be new to European Structural and Investment Funds funding and will not have a track record.

### 3. Contribution Rate & Match Funding

European Regional Development Fund is normally expected to intervene where no other funding can be obtained (i.e. the funder of last resort). The level of European Regional Development Fund awarded will be the minimum in order for the project to proceed.

The maximum Contribution Rate is 60% of the total eligible project costs subject to State Aid regulations.

The remaining 40% or more must come from other eligible sources as specified under section 6 of the National Eligibility Rules. Applicants will need to demonstrate that they have eligible match funding in place for the balance of costs. Other European Union funds cannot be used as a source of match funding.

European Regional Development Fund investment is limited by State Aid regulations and where the award of European Regional Development Fund would constitute State Aid the European Regional Development Fund grant rate may fall below the 60% maximum.

European Regional Development Fund is paid quarterly in arrears and expenditure must be defrayed prior to the submission of any Grant claims. Applicants may be asked to demonstrate how they are able to cash flow the operation.

### 4. Project Timescales

European Regional Development Fund funding will normally be approved for three years, however the Managing Authority reserves the right to extend the contract term in exceptional circumstances.

Projects approved through this call are expected to:

- Submit a detailed and complete full application within three months of formal selection at outline stage. Projects which fail to meet this deadline may be deselected,
- Commence delivery (defraying European Regional Development Fund eligible costs) within three months of formal approval. Projects which fail to meet this deadline may be deselected, and
- Be completed by June 2023.

### 5. Capital Projects

Applicants seeking European Regional Development Fund to support a capital project (i.e. land and/or property) will need to meet Building Research Establishment Environmental Assessment Method or Civil Engineering Environmental Quality Assessment 'Excellent' for new builds and 'Very Good' for refurbishments. Applicants will need to provide evidence of how they will achieve the rating required (unless otherwise agreed with the Managing Authority).

Applicants will need to demonstrate that they have the rights and permissions to undertake the project and must provide:

- 1. Proof of current interest in the land and/or property, which includes evidence of the freehold ownership or any lease arrangements that may be in place; and
- 2. Evidence of the approval of any planning permission, or in certain circumstances a clear statement on the process for securing such consents and any risks to the project.

Royal Institute of British Architects Stage D costs must be supplied with the Full Application and be certified by an independent Quantity Surveyor and Land/Property contributions certified by a Real Estate Valuation expert who are current and chartered members of the Royal Institute of Chartered Surveyors/ Chartered Institute of Builders or equivalent body.

Successful Applicants will be required to provide security to the Managing Authority in the form of a Legal Charge and/or Deed of Covenant over the land and/or property. Applicants will be responsible for registering the charge at their own cost.

### 6. Cross Cutting Themes/Horizontal Principles

All applications received under this call should demonstrate how the Cross Cutting Themes have been addressed in the project design and development. Cross Cutting Themes for European Regional Development Fund are 'equality and antidiscrimination' and 'sustainable development'. Further information is available in the European Regional Development Fund Operational Programme.

### 7. Additionality, Duplication and Displacement

Additionality is a core principle of European Regional Development Funding. Applicants must be able to demonstrate that the activity paid for out of European Regional Development Funding adds value to new or existing activity. Projects need to demonstrate that without the support of European Regional Development Funding the activity would not have taken place.

European Regional Development Funding cannot support activities that duplicate existing provision/services within the region.

Applications need to identify and evidence how the beneficiaries will use the service and demonstrate that the project does not displace other activity available in the market place.

### 8. State Aid & Revenue Generation

Applicants are required, in the Outline Application, to provide a view on how their proposal complies with State Aid law. Applicants must ensure that projects comply with the law on State Aid.<sup>1</sup> Grant funding to any economic undertaking which is State Aid can only be awarded if it is compatible aid, in that it complies with the terms of a notified scheme or is covered by the De Minimis Regulation. Guidance for Grant Recipients, explaining more about <u>State Aid</u>, is available; it is important that Applicants take responsibility for understanding the importance of the State Aid rules and securing their full compliance with them throughout the project, if it is selected into the Programme.

The Managing Authority is not able to give legal advice on State Aid. It is the responsibility of the Applicant to ensure that the operation is State Aid compliant.

Where the Applicant does not perceive that there is any State Aid, it should state whether or not it considers Articles 61 and 65(8) of regulation 1303/2013 to apply. Article 61 refers to monitoring revenues generated after completion of the project, and Article 65(8) how to deal with differences in the forecast and actual revenues at the end of the operation. This revenue should be taken into account in calculating eligible expenditure. The details of this will be tested at the full application stage.

### 9. Funding Agreement

The Funding Agreement is a standard, non-negotiable and legally binding document. Any successful Applicant will be subject to the terms and conditions contained within this agreement. Applicants are strongly advised to seek relevant advice to ensure that they would be able to enter into and abide by the terms of the Funding Agreement.

Applicants are advised that additional provisions and securities may be included within the Funding Agreement to protect the investment. Detailed advice will be given if appropriate at the Full Application stage.

Failure to meet any of the conditions of the Funding Agreement or the commitments within the application will result in claw back of the Grant (which may include interest).

### 10. Procurement

All costs claimed by the Applicant (Grant Recipient and/or Delivery Partner(s)) must be recovered on an actual cost basis. Other costs must be procured in line with National (including <u>Public Procurement Regulation 2015</u>) and European Union regulations. Procurement will be subject to audit and verification and any irregularity will result in financial penalty of up to 100% of the grant paid. Robust and transparent procurement is required to ensure that Grant Recipients:

- Consider value for money;
- Maximise efficient use of public money; and
- Maintain competitiveness and fairness across the European Union.

It is **strongly recommended** that Applicants seek and follow legal advice in respect of procurement requirements. Procurement irregularities remain the most substantive cause of error and clawback of grant.
