Research on use of pay-to-use cash machines

Summary

Kantar TNS were commissioned to undertake a general population survey designed to provide the CMA with a better understanding of the reasons why consumers choose to use pay-to-use cash machines instead of free-to-use machines, and the potential impact on their behaviour if a PTU ATM was not available.

Given the need to find a quick and efficient way to interview a low penetration group of respondents, questions were added to a large weekly sample face-to-face omnibus survey with the objective of delivering a minimum of 100 interviews amongst past four week PTU ATM users. There was no requirement to provide data at a detailed regional level, nor to identify users of either of the two competitor brands.

Interviews took place from 14th June through to 9th July 2017 across four face-to-face omnibus surveys. In total, the survey was asked of 8,444 adults aged 16+ from across the UK. A total of 349 different UK sample points were included for this survey.

At the outset, the estimated incidence of PTU ATM usage in the past four weeks was 1.5%. This was a cautious estimate based on known numbers of withdrawals per week in 2015 and a downward trend in usage of PTU ATMs, but with an unknown share of usage by international visitors and those under the age of 16 (neither of which would be represented within the omnibus survey) and by non-unique users (i.e. those UK adults age 16+ who make more than one PTU ATM withdrawal in a four-week period).

When we asked respondents if they had used a pay to use cash machine at any time in the past four weeks, a total of 411 users were identified, giving a higher incidence of 5.5% and thus providing a more robust sample size for analysis than originally anticipated.

The CMA also included a question to identify past three month users in case it was not possible to identify sufficient numbers of past four week users. The broader definition of PTU ATM users delivered a total of 573 interviews with respondents who had used a PTU ATM in the past three months, including those who had used PTU ATMs in the past four weeks.

A copy of the questions included in the survey appears at the end of this report.

Sampling Methodology

The Kantar TNS Omnibuses employ a random location methodology each week. A varying number of sampling points are issued depending upon the length of the questionnaire. The number of Great Britain sampling points issued can be 208, 192, 176, 151 or 143 and corresponding sampling points in Northern Ireland are 7, 5, 5, 4 or 4. The points used are sub-samples of those determined in a sampling system developed by Kantar TNS for its internal use.

Sampling Frame

2001 Census small area statistics and the Postcode Address File (PAF) were used to define sample points. These are areas of similar population sizes formed by the combination of wards with the constraint that each point must be contained within a single Government Office Region [GOR]. In addition, geographic systems were employed to minimise the drive-time required to cover each area as optimally as possible.

600 points were defined south of the Caledonian Canal in Great Britain [GB]. Another 25 were defined in a similar fashion in Northern Ireland. Finally, 5 points were defined north of the Caledonian Canal. These latter differ in size from the other points and each other to meet the need to separately cover the different parts of the Highlands and Islands.

Stratification and Sample Point Selection

415 points were selected south of the Caledonian Canal for use by the Omnibuses after stratification by Government Office Region and Social Grade. They were also checked to ensure they are representative by an urban and rural classification. Those points are divided into two replicates. One set is used in one week. The other set is used in the next week. One of the points north of the Caledonian Canal is also used. 14 of the points in Northern Ireland are selected and divided into two replicates. Those replicates are used in rotation to give a wide spread across the Province over time. Similarly, the statistical accuracy of the GB sampling is maximised by issuing sequential waves of fieldwork systematically across the sampling frame to provide maximum geographical dispersion. This ensures that the sample point selection remains representative for any specific fieldwork wave.

Selection of Clusters within Sampling Points

All the sample points in the sampling frame have been divided into two geographically distinct segments each containing, as far as possible, equal populations. The segments comprise aggregations of complete wards. For the Omnibuses, alternate A and B halves are worked each wave of fieldwork. Each week different wards are selected in each required half and Census Output Areas selected within those wards.

Then, groups of OAs containing a minimum of 200 addresses are sampled in those areas from the PAF (a maximum of 250 addresses are issued per assignment).

Interviewing

The addresses, selected as above, are issued to achieve an adult sample of 10, 11, 12, 14 or 16 interviews in provincial areas, and 10, 10, 11, 14 or 15 in London, depending upon the questionnaire length. Assignments are conducted over two days of fieldwork and are carried out weekday 2pm-8pm and at the weekend. Quotas are set by gender/housewife. Within female, presence of children and working status is set and within men, working status is set, to ensure a balanced sample of adults within effective contacted addresses. All interviewers must leave 3 doors between each successful interview.

Weighting and Demographic Analysis

In addition to fieldwork back-checks on the quality of interviewing, further checks are made to ensure that respondent details, including postcode, are complete and that answers to the survey and demographic questions are present. Any incomplete interviews are removed before the data is processed for weighting and analysis.

The results of the four surveys were combined and weighted to represent the adult population. An interlocked 72-cell matrix was employed with Gender, Age (16-24, 25-34, 35-54, 55+), Social Grade (ABC1, C2, DE) and grouped Government Region controls.

The total number of interviews used for final analysis was 8,444. Once the data was weighted on the above criteria, the effective sample size was calculated as 7,742.

In addition to the CMA's questions, demographic analysis was included covering:

- Gender
- Age
- Social grade
- Working status
- Presence of children
- Country
- Population density
- Ethnicity

Where questions allowed for respondents to give an answer not already listed, the verbatim responses were reviewed following fieldwork and the following small number of edits were made to the final results:

Q7 – Two more answer codes were added to summarise answers given by a total of 18 respondents:

- Amusement arcade/pier/promenade
- Fast food/restaurant/takeaway

A further eight answers were re-coded from "Other" into existing pre-codes.

Q12 - Three new answer codes were added, covering a total of 14 responses:

- Pay for games/rides
- Pay for fuel
- Make a donation

A further 41 answers were re-coded from "Other" into existing pre-codes.

Q13 - Two new codes were added, covering a total of 14 responses:

- The recipient could only be paid in cash
- Chip and in machine/card reader was not working

A further 16 responses were re-coded from "Other reason" into existing pre-codes.

Q19 – Three new codes were added, covering a total of 26 responses:

- £5 notes were available
- FTU machine was out of order/empty
- It was the closest/handiest one

A further 16 responses were re-coded from "Other reason" into existing pre-codes.

Q20 – One new code was added, covering a total of 11 responses:

• Borrowed money from someone

A further 14 responses were re-coded from "Something else" into existing pre-codes.

INTERVIEWER READ OUT
