Re: Agreed basis for the provision of information and assistance by Ofcom to the CMA in relation to the proposed Fox/Sky merger

Further to your letter of 25 September setting out an agreed basis for the provision of information and assistance by Ofcom to the CMA, we have identified a number of Ofcom internal papers that may be helpful to you in the carrying out of your functions, and which we propose to share with you under our duties set out in s.105(4A) of the Enterprise Act 2002.
