## FREEDOM OF INFORMATION ACT 2000 REQUEST REF: 0019-14

Thank you for your emails of 6, 7 and 8 January 2014 asking for information under the Freedom of Information Act 2000. You refined your request as follows:

My request now stands as dates for all visits made and received by William Hague by their foreign counterparts (other Foreign Secretary's). Please could you provide this information for the duration of David Cameron's term.

If it makes the request more manageable, I am only interested in visits made to/from the following countries:

Saudi Arabia, UAE, Qatar, Oman, Turkey, Kuwait, Jordan, Singapore, Malaysia, Indonesiam Israel, Japan, India, Australia, Thailand, RoK (South Korea)

I am writing to confirm that we have now completed the search for the information which you requested.

I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request.
