Your correspondence dated 4 August 2015 has been considered to be a request for information in accordance with the Freedom of Information Act 2000. You requested the following information:

*A breakdown of all Ministry of Defence and British Army funding amounts given to Chatham House up to 2015 and any future planned/allocated spend. I would like the total amounts given and information on specific projects funding was given for, if any.*

I am writing to confirm that Ministry of Defence (MOD) holds information on the subject you have requested. However, I have to advise you that we will not be able to answer your request without exceeding the appropriate limit. This is because to locate, retrieve and extract information in scope of your request would involve contacting every department within the MOD to determine if there is any future intended or allocated expenditure planned because this information is not centrally held, at least some 15 man days of effort.

Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, and locating, retrieving and extracting it.

The MOD may be able to provide some information in scope of your request if you reduce or refine your request to bring the cost of compliance under the limit. This might be by requesting this information for specific Departments/areas of the MOD and/or specifying a precise time frame.

Please contact me if you would like to refine your request or require advice on doing so.

Under Section 16 of the FOIA, public authorities are required to provide advice and assistance while processing FOI requests, and I have therefore included some additional information below that you may find useful.

The table below contains the originator department of the payment and the amount authorised for the last 5 financial years.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1<sup>st</sup> Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
