2014 summary report for UK bathing waters monitoring results under the Bathing Water Directive

This report is based on data provided to the European Commission under Article 13 of Directive 76/160/EEC (the Bathing Water Directive), as amended by Article 3 of Directive 91/692/EEC. It provides a summary of the results of the 2014 survey of the quality of United Kingdom bathing waters included within the scope of the Bathing Water Directive.

Section 1: Changes from the 2013 list of designated bathing waters

Five new bathing waters were designated in 2014:

- Collieston (Scotland)
- Henleaze Lake (South West)
- Llyn Padarn (Wales)
- Rhyl East (Wales)
- Shoreham Beach (South East)

Two bathing waters in England were dedesignated, both in the North West:

- Askam-in-Furness
- Roan Head

No results were recorded at Newhaven (South East region), where access to the beach remained closed during the 2014 season.

The names of three bathing waters in England were amended at the request of the local authority or private owner:

Section 2: Bathing season and sampling frequency

The bathing season normally runs from 15 May to 30 September in England and Wales, and from 1 June to 15 September in Scotland and Northern Ireland. Throughout the UK a minimum of 20 samples are usually taken throughout the season. This is in excess of the minimum requirements of the Directive. In 2014 the beginning of the bathing season was delayed at six bathing waters in England and one in Wales. Repair work was being carried out at the access points at Plymouth Hoe East and Plymouth Hoe West in South West region, which reopened on 21 May; at Ingoldmells South in Anglian region, which reopened on 25 May, and at Teignmouth Holcombe in South West region, which was closed to the public until 19 August. Shoebury East in South East region was closed until 23 June because of the discovery and removal of ordnance on the beach. In Wales, Caerfai was closed until 13 June because of safety concerns at the access point.

Sampling frequency has been reduced at eight Scottish bathing waters in accordance with footnote (1) of the Annex to the Directive.

Section 3: Parameters

2014 is the final year of the transitional period, when the revised Bathing Water Directive's (2006/7/EC) parameters are used to assess compliance with the standards set by the original Directive. Sampling for *E.coli* and intestinal enterococci is used to assess compliance with the standards for faecal coliforms and faecal streptococci respectively. Sampling for total coliforms and for the physicochemical standards of Directive 76/160/EEC was discontinued in 2013.

The tables contain a numerical summary of the information required to assess compliance with Directive 76/160/EEC's mandatory faecal coliform standards. They are arranged to show the British coastal bathing waters in clockwise order, starting at Southernness, which is the most south-westerly bathing water in Scotland, and proceeding around Scotland, England and Wales to Silloth in the Environment Agency North West region. The Isle of Wight waters are placed in the report between Highcliffe and Christchurch, that is to say, as the last waters in the Environment Agency South East Region. The Northern Ireland waters are reported in clockwise order from Magilligan to Cranfield Bay. The summary of the information for freshwater bathing waters is given after the information about coastal bathing waters.

Intestinal enterococci

Article 3.7 of Directive 2006/7/EC allows the monitoring calendar to be suspended in the event of an abnormal situation, which is defined as an event or combination of events impacting on bathing water quality at the location concerned and not expected to occur on average more than once every four years (Article 2.9). Public information must be displayed about the nature and expected duration of the incident.

Ten bathing waters in England, one in Scotland and one in Wales have been affected by abnormal situations in 2014.
