In addition to the statistical release, a statistical story has been issued in parallel as a ad hoc piece of analysis. This analysis was carried out by social researchers and quality assured by statisticians. There were two options for publishing this analysis. Whilst a research report was considered, it was finally felt that the work would be better presented alongside the regular statistical publication as a statistical short story.

During its development as a research report, a number of senior officials and analysts in the Home Office and partner bodies were consulted during the design, development, data collection and analysis. They were also involved in the quality assurance of the work. In addition, Ministers were advised of top-line findings of the analysis as part of a briefing for publication of David Anderson's 2012 report in July 2013 given his previous references to this topic in his report.

However, once it was finally agreed to release the analysis as a statistical short story, in the weeks running up to publication, only the production teams had access to the analysis in its 'final form' before it was circulated together with the regular terrorism arrests publication under the 24 hour prerelease access arrangements.
