TITLE: Provider Appraisal Update

Summary:

- There has been one new assessment referral this month, St George's Healthcare NHS Trust. This represents the first referral from the NHS Trust Development Authority (NHS TDA) since the implementation of the Chief Inspector of Hospitals' enhanced inspection regime.
- The review of the Royal Free London NHS Foundation Trust's acquisition of Barnet and Chase Farm is nearing completion. Work has commenced on the Frimley Park Hospital NHS Foundation Trust acquisition of Heatherwood and Wexham Park NHS Foundation Trust with submissions due mid May. This transaction will be the first statutory transaction that is assessed by Monitor following the new legislation. Monitor is required to approve the transaction and it is expected that the decision will be referred to the Board.
- The consultation response to the new transaction approach has been issued, the Risk Assessment Framework has been updated for the revised approach and plans are in place to issue the detailed guidance by June 2014. Training will be rolled out to the team in Q1.
- In addition, the team is working on developmental projects including financial assumptions work, transaction guidance, reactivation of paused assessments and aligning the 'Well Led' framework. A joint statement with the NHS TDA and CQC was published on 20 May setting out how we are aligning our approach on Well Led. This was timed with the release of the framework and the consultation response to governance reviews for NHS FTs.

A. Developments

NHS TDA

- 1. The Provider Appraisal directorate continues to engage with the NHS TDA to streamline the end-to-end assessment process.
- 2. The NHS TDA has drafted an updated scope for accounting firm work on NHS foundation trust (NHS FT) applicants pre referral to Monitor. The Provider Appraisal directorate has provided feedback on this primarily in relation to:
 - (i) the implications for and efficiency of Financial Reporting Procedures and Working Capital opinions required in the Monitor phase, and
 - (ii) ensuring clarity of scope for new types of reports by accounting firms.
- 3. A joint meeting with Monitor, the NHS TDA and accounting firms has taken place. The NHS TDA is currently considering the feedback from the accounting firm before concluding on a revised scope.
- 4. The Provider Appraisal directorate has initiated discussions with the NHS TDA to identify a potential next set of trusts for early quality governance review. It is likely that we will be asked to undertake two such reviews in June.

CQC "Well Led"

5. The joint statement by Monitor, the Care Quality Commission (CQC) and the NHS TDA which describes the "Well Led" framework and how our respective regulatory processes align has been published. Wording has been agreed with Strategy and Policy team colleagues to ensure that it is consistent with Monitor's approach to governance reviews.

B. Update on assessments

6. Annex 1 provides details of the applicants currently being assessed by the team.

Referrals

7. There has been one referral this month: St George's Healthcare NHS Trust (refer below).

Active assessments (exception reporting)

- 8. St George's Healthcare NHS Trust: This represents the first NHS TDA referral for assessment following the instigation of the Chief Inspector of Hospitals' new CQC inspection regime. An assessment team has been resourced to commence a full assessment from mid May 2014.
- 9. Royal United Hospitals Bath NHS Trust: CQC has now written to Monitor to confirm the results of the Chief Inspector of Hospitals inspection which supports progression to NHS FT authorisation. A team has been resourced to reactivate this assessment with a Board to Board planned for August 2014.

Delayed, deferred and postponed trusts (exception reporting)

- 10. Monitor has attended quality risk summits held with regards to Devon Partnerships, Coventry and Warwickshire Mental Health and Cornwall.
- 11. Monitor has also attended a quality risk summit for Bridgewater Community.
- 12. The Provider Appraisal directorate is seeking an update from the CQC on all inspection pilots relating to non-acute trusts in order to understand the implications for deferrals and status in the cases where the CQC have not given support for NHS FT applications.

Assessment Pipeline

- 13. An overview of the assessment pipeline is provided in Annex 2. This reflects the NHS TDA's latest available public forecast (January 2014) updated for the referral of St George's Healthcare. The NHS TDA forecast indicates that 12 NHS trusts "are not considered sustainable in their current form and are therefore pursuing an organisational transaction". This leaves a total of 71 NHS trusts to be referred to Monitor.
- 14. It is difficult to predict the number of referrals going forward, as the pipeline is dependent both on the outcome of the CQC inspection and the financial position of the NHS TDA trusts. There is ongoing engagement with the NHS TDA to understand the expected pipeline over the next six months.

C. Update on transactions

15. Work is ongoing to complete the transaction guidance document for trusts considering a transaction, consolidating existing information and updating Monitor's approach for new developments, for example the Health and Social Care Act 2012. The provider appraisal team expects that the new approach to transactions and the updated guidance documentation will be implemented in Q1 2014/15 and is aiming for the transactions guidance to be published in June 2014 alongside the Co-operation and Competition directorate/Competition and Markets Authority's guidance.

Active projects

- 16. Royal Free London NHS Foundation Trust acquisition of Barnet and Chase Farm Hospitals NHS Trust.
- 17. Frimley Park Hospital NHS Foundation Trust's acquisition of Heatherwood and Wexham Park NHS Foundation Trust: an assessment team has been resourced and has requested certain information from both trusts in advance of receiving a Final Business Case. The proposed transaction completion date is 1 August 2014.
