# REQUEST FOR INFORMATION: THE BRITISH HORSE SOCIETY ONLINE RAGWORT SURVEY

Thank you for your request for information, which we received on 13 August, about the British Horse Society online ragwort survey. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA). I apologise for the delay in sending you the information below. We are currently experiencing a high number of FOIA/EIRs requests making it difficult to respond within the deadlines. It has also taken some time to gather the relevant information together and ensure you have a full and accurate response to your request.

The terms of your request are as follows:

"A ragwort survey was recently announced by the British Horse Society in conjunction with Defra. This is a Freedom of Information request asking for all documents, emails and letters or any other record of communication relating to the design, approval, and construction of the survey including the nature of the questions to be asked."

We are withholding the names and contact details of those involved in the correspondence under the exemption at section 40(2) of the FOIA, which relates to personal data of persons other than yourself (the requester). Section 40(2) of the FOIA provides that





personal data relating to persons other than the requester is exempt information if disclosure would breach the Data Protection Act 1998 (DPA). We consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 to the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute 'fair' processing of the personal data and, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA. Therefore, we have concluded that this information is exempt from disclosure under section 40(2) of the FOIA.

As mentioned in Defra's acknowledgement letter to you, Defra's policy team would always be open to discuss with you the development of ragwort policy without the need for you to formally submit EIRs/FOIA requests if you would prefer that (please contact at ).

In keeping with the spirit and effect of the FOIA, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on www.gov.uk together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
