Both the SME and non-SME samples were obtained from Dun and Bradstreet<sup>1</sup>, and selected according to the appropriate ratios by size and broad sector in order to be representative of the populations within England, Scotland, Wales and Northern Ireland. It should be noted no organisations were contacted more than once to participate in this research, with any duplicate contact details being removed before interviewing started. Tables A2.3 and A2.4 show the total achieved samples sizes for both the non-SME and SME surveys.

# Annex A.3: Limitations of the methodology

The analysis of data from the interviewed businesses was limited by the relatively small sample size of the sub-groups. Therefore, the analysis of sub-groups carried out provides broad observations of the data and should be taken as indicative. Some questions were added in later waves of the survey, and in these cases the sample sizes were smaller. Moreover, not all the same questions were asked to SMEs and non SMEs, limiting the potential to compare the findings between these groups in all cases. Cautionary statements have been added where base sizes impact on the robustness of findings.

Social desirability bias (i.e. the tendency of survey respondents to answer questions in a manner that will be viewed favourably by others) is always a risk in surveys wherein the levels of 'right behaviour' are being measured. Within the non-SME strand, social desirability bias may cause respondents to over-report on favourable audit behaviour and compliance with ESOS. For SMEs, this bias may cause respondents to over-report on audit and energy efficiency behaviours. In a similar vein, all surveys pose the risk of framing effects (i.e. people reacting to a particular choice in different ways depending on how it is presented). Interviewers are instructed to follow the questionnaire wording and quality control monitoring is conducted to ensure that this is the case. This minimises disparities in how questions and response codes are presented, encouraging consistency across all interviewers and waves. Although questions were piloted, there was no cognitive testing of the questionnaire, meaning that interpretation of questions and whether their presentation had any impact on understanding and responses was not fully determined.

Due to budget and timing constraints, the pragmatic approach of sampling by quota was taken across both strands – this approach can result in selection and sampling bias. Data was subsequently weighted by size and sector to address the issue of under-representation for certain groups (compared to the target population).

# Annex A.4: Weighting and Confidence intervals

To ensure non-SME data are representative of the target population both the SME and non-SME data have been weighted. For the non-SME results, the combined data across the four completed waves have been weighted by size and broad sector, as outlined in Table A4.1

Unless otherwise stated, all differences between sub-groups and non-SMEs/SMEs outlined in this report are statistically significant at the 95% confidence level. In effect, this means there is only a 5% probability that the difference occurred by chance.
