Answer: If you are considering linking or joining a scheme with an existing one, your bid should demonstrate how the proposals will build on and complement existing actions. Funding cannot be used to replace funding for an existing project. It can, however, be used to extend the geographical coverage, scope or scale of an existing project.

Hi, re: Collective Purchasing and Switching, we anticipate using DECC support to test the viability of our proposed business model, ensure contractual/procurement processes are robust and ultimately ensure we have a marketable product at 31st March. In the event we find through this process that the business model doesn't stack up, is 'don't proceed' an acceptable (albeit unwelcome) result for you?

In Cheaper Energy Together, would items such as promotional vehicles be eligible for funding, eg a bus that toured local communities?

Answer: We do not want to be too prescriptive about the sorts of activities which can be funded through the fund. Your bid, however, should demonstrate how the proposals will deliver value for money against the stated objectives and criteria, which has a large weighting in favour of engagement with vulnerable consumers. Funding could be used for contractual and procurement processes, specialist external advice and a vehicle for marketing

and advertising of the scheme, but you will need to set out the full range of the costs and benefits that will result from the investment.

I am aware that Community Buildings are looking at extending Collective Buying into Cheaper Energy Together. As Community Buildings are community hubs would they be eligible for funding to demonstrate the benefits?

I live in a rural part of northern England I would like to submit a community based bid from local parish council, for collective energy switching do we need sign off from the Council? I dont want to compete with them but I feel the community based model is most suitable to this rural area.

Local Authorities and eligible third party sector organisations are invited to bid for funds to develop collective purchasing/switching funds. Third party sector organisations can bid separately from local authorities.

Eligible third sector organisations must be legally constituted organisations and includes Charities, Parish Councils, Community Interest Companies, Community Co-operatives and Community Benefit Societies, Voluntary Associations, Development Trusts, Faith Groups, Registered Social Landlords. Funding will not be available for commercial activity.

Plus can you clarify the payment in arrears period is it 30 days or more than this?

Answer: For the Cheaper Energy Together fund, DECC would be willing to discuss the timing of payments and ways to prevent cash flow problems to small organisations. This would be on the basis of demonstrating a clear operational requirement and would need to be discussed on a case-by case basis with the bidder.

Answer: For the Cheaper Energy Together fund, DECC is unable to provide funding for activities that take place after the 31 March 2013 therefore all activity must be completed by that date.

Answer: DECC funding cannot be used to support commercial activity however we will consider bids that have private sector partners. Bidders must comply with State Aid rules.

Answer: We have not yet specified the full set of data we would like to collect from the successful schemes though this is likely to include numbers of consumers switching, demographic information and savings they are expected to make. The application form has requested information on the customers the scheme is expected to engage with but has not set targets for this.

For some this may be collective switching, but for others a tailored, individual service to switch to a better tariff may be more appropriate. Can this all be covered under the "Cheaper Energy Together" bid or would we need to include the individual support and switching in our Fuel Poverty bid?

Answer: In the Cheaper Energy Together fund we will consider bids that propose individual switching advice so long as this was in conjunction with an offer to take part in a collective switching or purchasing scheme, which is the main purpose of the fund.

Answer: You can be involved in both a collective and individual application. The key thing to think about in preparing your bid will be to demonstrate how the bids are distinct with no overlaps – obviously we'll need assurance that we're not making multiple grants for the same projects.

Answer: Hi Bernie. I wanted to answer this question from a Fuel Poverty Fund perspective. We will need measures to be installed by the 31st of March, as we would not be able to provide funding for any measures installed after this date. We recognise that there is a lag time between identifying households in need of support and the installation of measures; this is something that you will need to factor in when designing a timetable for your proposal. Thanks.

10:20	Dionne Jones	Is there a limit on the amount of revenue grant available for the Fuel Poverty Fund?

Answer: Hi Dionne, we just want to clarify the answer we gave to your question, which focused on size of bids rather than the revenue portion of bids. There is a limited amount of programme (revenue) grant available overall, but we aren't putting a cap on the percentage of a bid that can be programme and/or capital. Bids will be considered on a case by case basis, so we just ask you to be clear about the level and type of funding you are looking for, and your justification for its use in delivering the fund's objectives.
