## Welcome to the second issue of Good Law News

Civil Service Live, 2<sup>nd</sup> July 2013

Civil Service Live gave us a great opportunity to share the good law initiative with a wider cross-section of Civil Service colleagues. At the "instant legislation booth" (in the policy hub), parliamentary drafters were on hand to work with delegates to turn their policy idea into an "instant" draft clause. This worked really well as a way of exploring the policy detail needed to turn a proposal into law.

We also ran a well-supported workshop — "the Good Law approach — why legislation matters" - which kicked off with presentations from panellists including the Deputy Leader of the House of Commons (Rt Hon Tom Brake MP), Lord Phillips of Sudbury and John

Sheridan from the National Archives. Workshop participants then got the chance to play "Legislate?!", our interactive board game which takes players on a journey through the legislative process, from development of a policy idea to implementation, with plenty of scope for exploring causes of complexity along the way. The competitive spirit in the room and comments from players suggested that the game worked very well.

"The OPC operated an "instant legislation booth". We used our drafting software to instantly turn short policy suggestions into clauses. The intention was to offer an insight into the drafting process. I drafted a range of provisions on serious and not-so-serious issues, such as a clause making "dress down Fridays" compulsory. The individuals who "instructed" us enjoyed the process, probing us on our drafting choices and challenging certain decisions. One commented that they had not appreciated how challenging it can be to turn even the most simple of policies into legislation, and how much thought is required to fully explore the implications of a policy. Another felt that the exercise illustrated the need for all persons involved in making legislation to work together in order to make clear and effective law."

"The OPC is working with officials in the Legislation Offices of the Lords and Commons and with a range of other partners on developing proposals designed to enhance the way legislation is prepared to make it more effective on the web. Officials are looking at the whole cycle of legislation, from drafting to amending to publication and archiving. A primary focus, subject to the normal approvals procedures, is developing an XML-based legislative drafting tool so that bill data is available in a more reusable form online, but it is hoped that developments will assist in the drafting of statutory instruments too. As well as the two Legislation Offices and OPC, colleagues involved come from The National Archives, the Office of Scottish Parliamentary Counsel and the Scottish Parliament. Further details will be publicised as they become available."
