United Kingdom Milk Prices and Composition of Milk – December 2013

Key points

This release shows the latest information on average farm gate milk prices and the butterfat and protein content of UK produced milk. The key results for **December 2013** are given below:

- A slight reduction in prices paid to milk producers by the majority of dairies have resulted in a UK average farm gate milk price of 34.3 pence per litre (at current prices), a 14% increase on the December 2012 price.
- The average butterfat content of UK milk was 4.11 per cent, 1.7% lower than a year earlier in December 2012 (4.18 per cent).
- The average protein content of UK milk was 3.33 per cent, slightly higher than a year earlier in December 2012 (3.30 per cent).

Section 1: United Kingdom farm gate milk price



Section 2: Composition of milk in the United Kingdom

Table 2 shows the average butterfat and protein content of milk. Butterfat content figures are sourced from published RPA figures and are presented here for reference only. Protein content figures are calculated from UK milk survey data.

Section 3: Methodology, Notes and Revisions Policy

- 1. The information in this notice is used by the UK government and the EU as evidence for assessing market conditions and evaluating agricultural policy. The prices are also required by the EU under regulation 479/2010, Article 2 (3)(a). Other users include the food and farming industry, academia and the general public. Contact details are available on the front page of this notice, for you to send feedback or ask questions about the information provided.
- 2. Farm gate milk prices: Defra runs a compulsory monthly survey of dairies in England and Wales to collect information on the volume, value and protein content of milk purchased from farms in England and Wales. All major dairies purchasing over 2 million litres of milk a year (33 in England and Wales) take part in the survey. Similar surveys are run by RERAD in Scotland and DARD in Northern Ireland which are used to calculate UK average prices.
- 3. The total volume of milk recorded by the surveys is compared with information from the Rural Payments Agency on the volume of milk delivered to dairies (information which is collected under milk quota regulations). The milk prices surveys cover approximately 90 per cent of milk purchased from farms in the UK.
- 4. The published farm gate prices are weighted according to the volume of milk purchased by dairies. The averages are strongly influenced by the larger milk purchasers, and smaller purchasers have little influence on the UK weighted average. The farm gate price is the average price paid to producers, net of delivery charges. No deduction is made for superlevy. Some purchasers pay bonuses retrospectively to producers. When this happens the bonus is split across the relevant months, and applied to the "including bonus" prices shown in Table 1.
- 5. Composition of milk: The Rural Payment Agency collects information on the butterfat content of milk delivered to dairies under the milk quota regulations. The information is published on the RPA website (www.rpa.gov.uk) and is repeated here for convenience. The RPA also collects information on the average protein content of milk, but only from larger purchasers. This information is supplemented with information from the milk prices surveys to obtain a UK average. In the same way as for the average prices, the average butterfat and protein contents are weighted according to the volume of milk purchased.
- **6.** The data are subject to a variety of validation checks which identify inconsistencies in the data. All data are cleaned prior to publication in discussion with the survey respondents.

Revisions policy

- 7. Figures in this notice are provisional and subject to revision. We will provide information about any revisions we make to previously published information in this statistics notice, and the associated datasets. Revisions could occur for various reasons, including:
 - a. if we have not received survey data from respondents we make an estimate based on their previous returns. These estimates are replaced with actual figures when they are received.
 - b. survey respondents occasionally supply amended figures for previous periods.
 - c. receipt of amended data from Scotland and Northern Ireland.
 - d. payment of retrospective bonuses which affect the "including bonus" price.
- 8. This month there are minor revisions to previously published figures from August 2013 due to amended Scottish data.
