#### Information request

The number of people who are currently on secondment from the Department for Business, Innovation and Skills (BIS).

For each secondee, please provide the following information: the position of the secondee at the organisation they are seconded to; the name of the organisation that they are seconded to; the duration of the secondment, including the start date and end date of the secondment; the BIS policy team the secondee worked at before the secondment; the position of the official to whom the secondee reports to at the organisation.

Please state how many individuals from external organisations who are currently on secondment within BIS.

For each secondee please state the name of their home organisation. For each secondee, please provide the following information: the position of the secondee at BIS; the organisation that the secondee is from; the duration of the secondment, including the start date and end date of the secondment; the BIS policy team they are currently working at; the position of the BIS official to whom the secondee reports to.

### Information released

The tables at Annex A provide the information about those who are currently (January 2014) on secondment in to the Department for Business Innovation and Skills (BIS) and those BIS staff who are currently out of the Department on secondment and to which company. Each entry in the table represents one person.

We estimate that to find the information for any entries marked "unknown" in Annex A would exceed the cost limit of £600 provided under Section 12 of the Act which represents the estimated cost of one person spending 24 working hours (3.5 working days) determining whether the Department holds the information; and locating, retrieving and examining the information held on individual staff files and in individual secondment agreements. The Act provides that we are not obliged to comply with requests where the estimated cost of complying would exceed this limit. Therefore, this part of the request will not be processed further.
