Thank you for your freedom of information request of asking for animal fatality data. I am writing to confirm that we have now completed our search for the information.

In your email of 11 November 2016 you asked the following questions:

- Please provide the number of dead animals found on roads from 2011 to 2015 inclusive, broken down by calendar year.
- If possible, please break down the figures by animal type.

The requested annual data is shown in the table below:

2011	2012	2013	2014	2015
2192	1907	1632	2027	2143

Data is only available from the start date of our current maintenance contracts; therefore the 2015 figure is the only year for which a full set of information is available.

The above data cannot be fully broken down into animal type, as much of the data is not held in a searchable format. Where such information is held on record at that level of granularity, it is broken down in the table at Annex 1.
